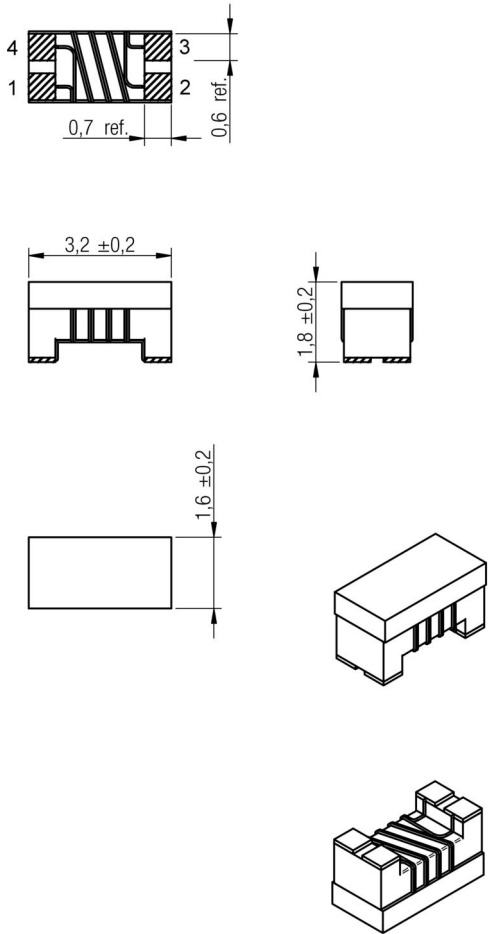

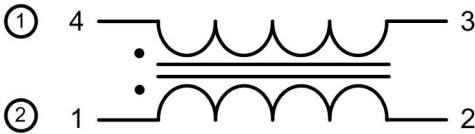

Differential Mode

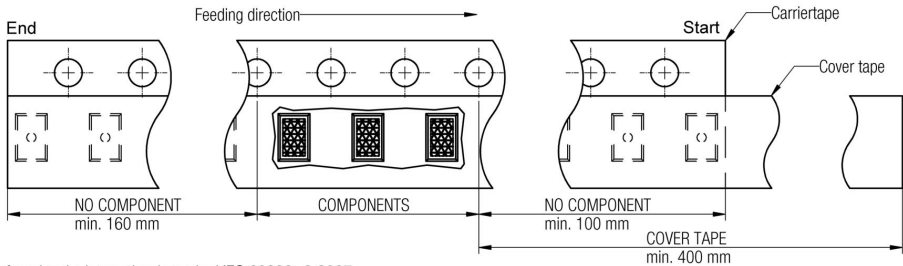
