Schematic:



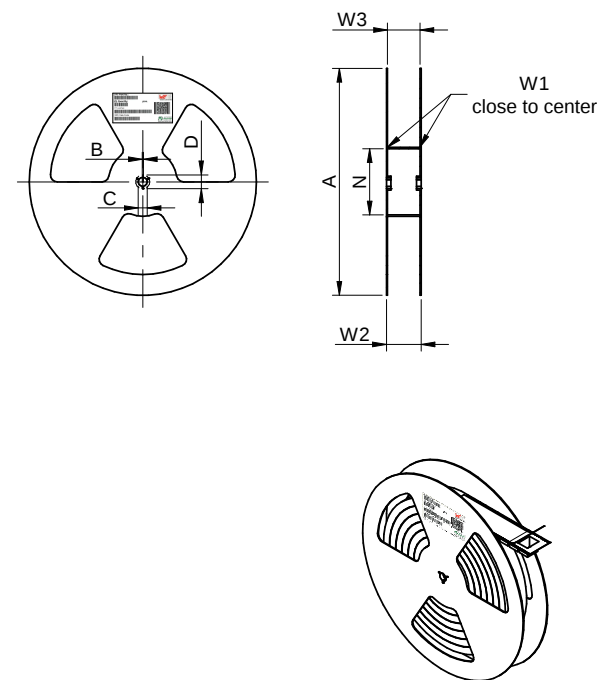
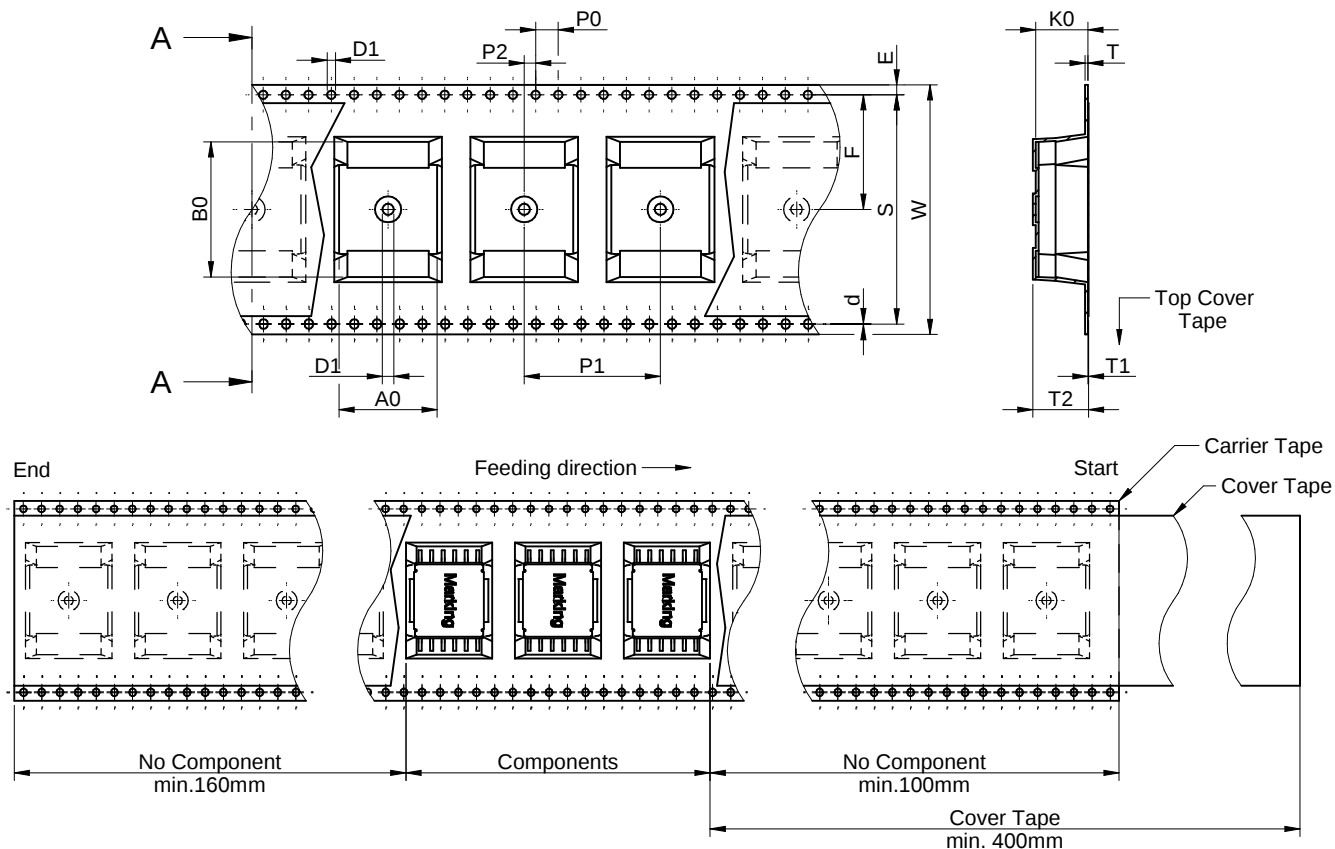
