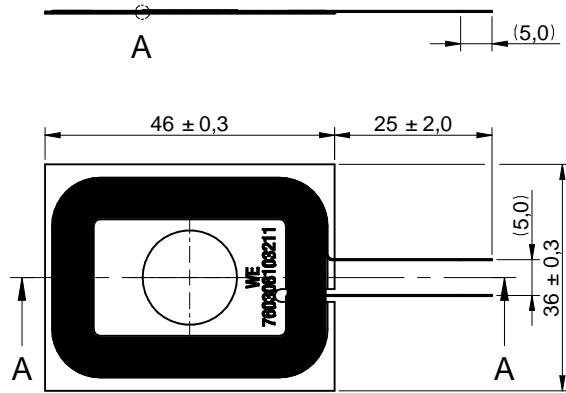
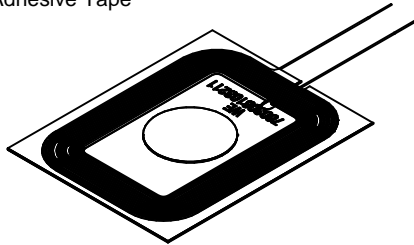
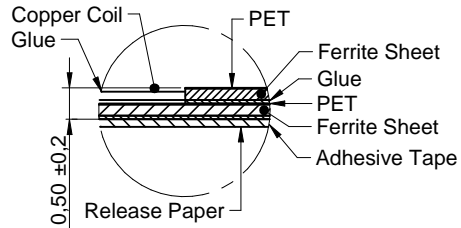

sectional drawing A-A

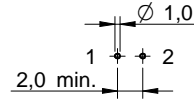

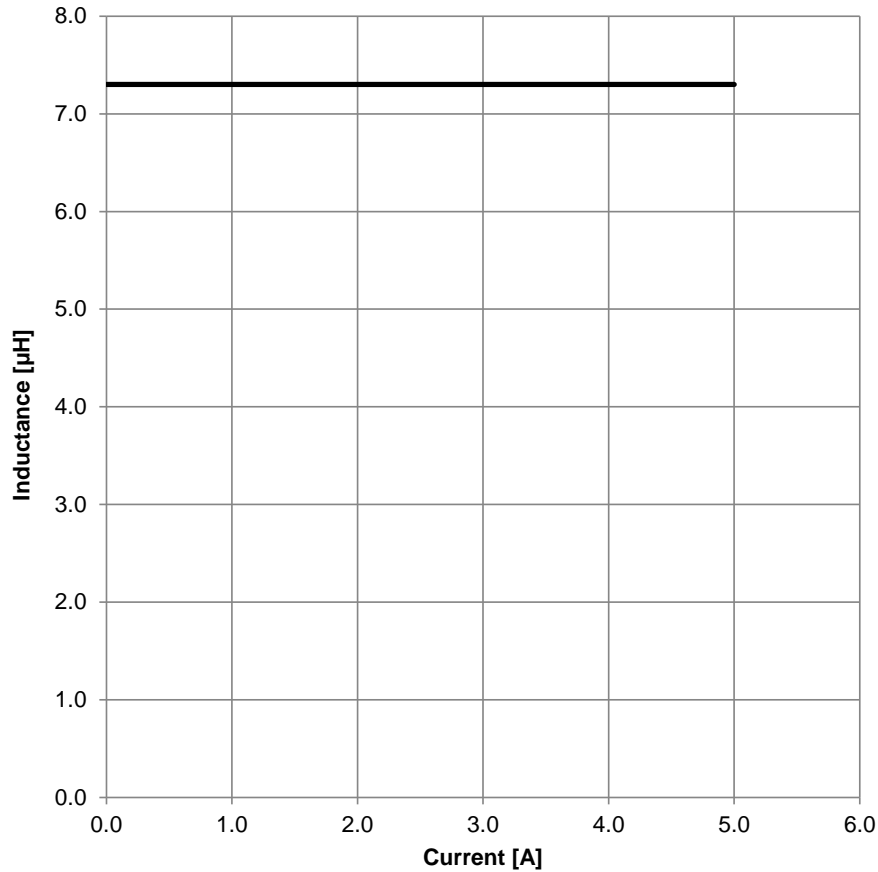

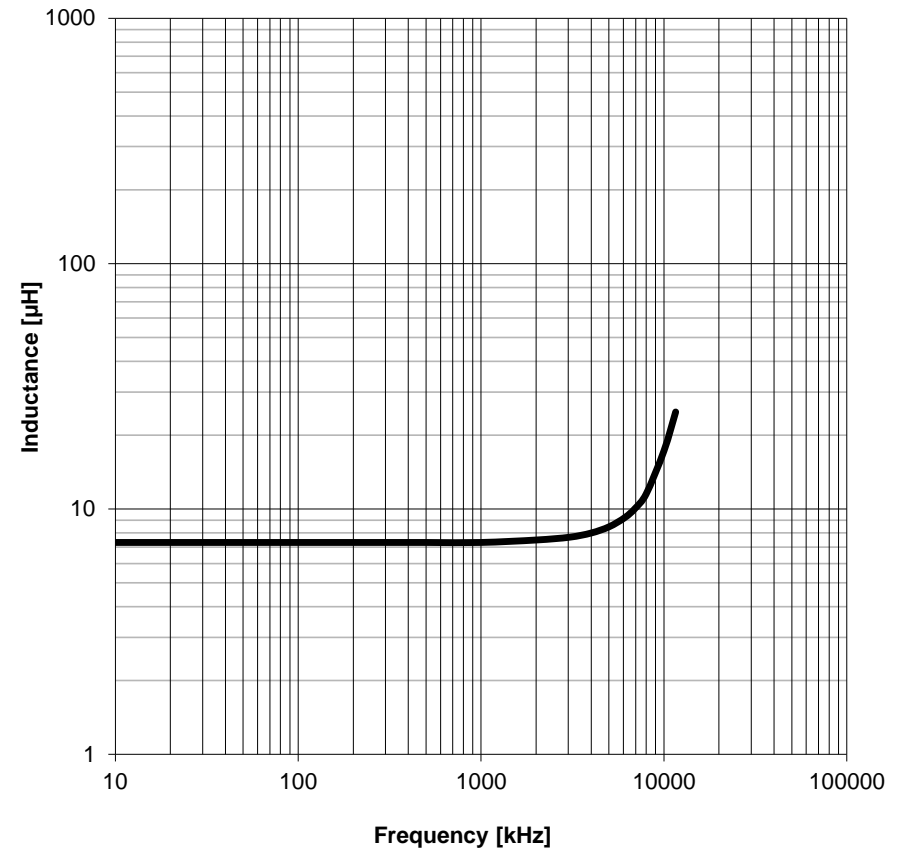

Typical Inductance vs. Frequency Characteristics:



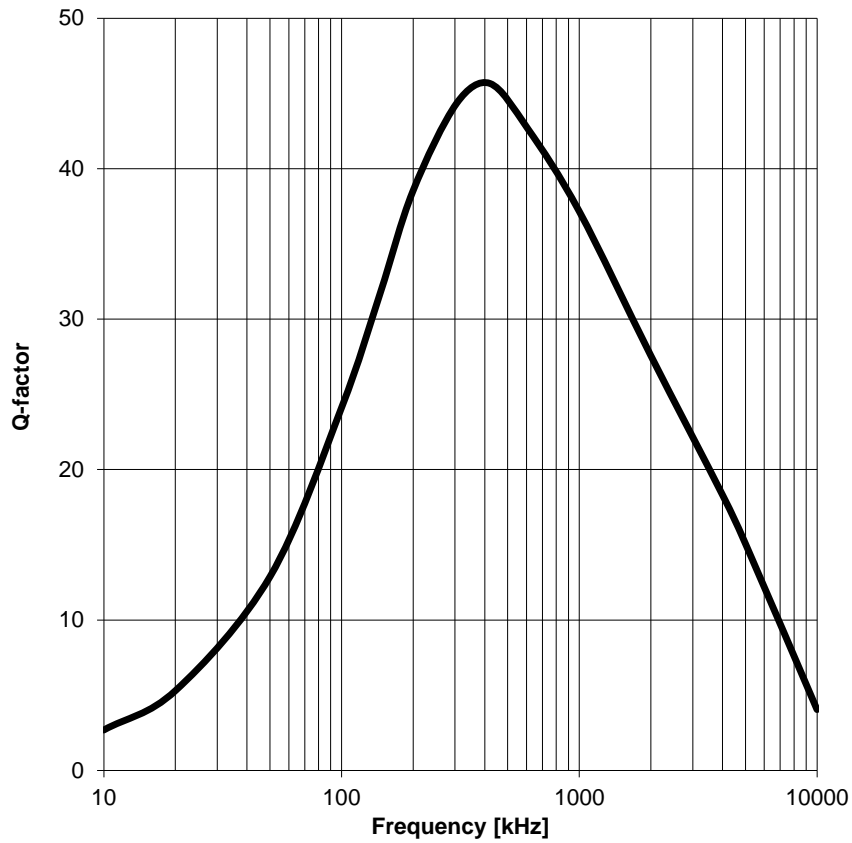

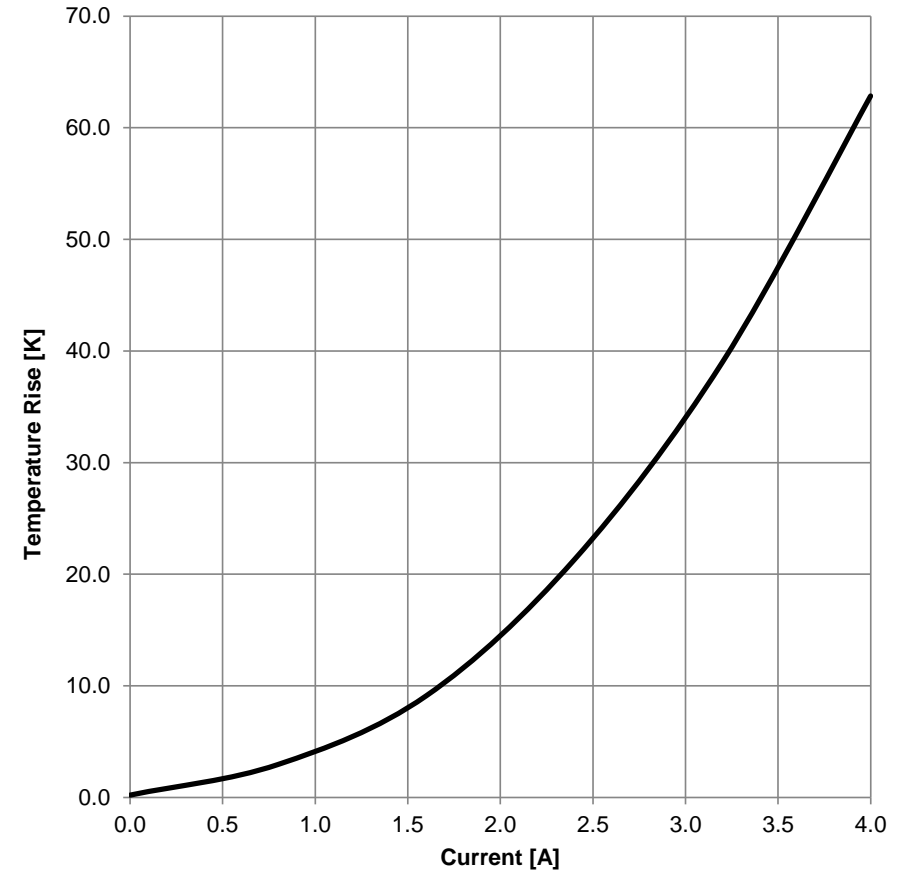

Typical Temperature Rise vs. Current Characteristics:


