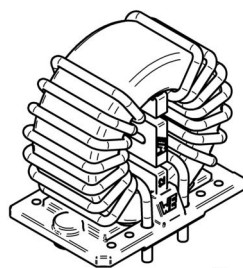

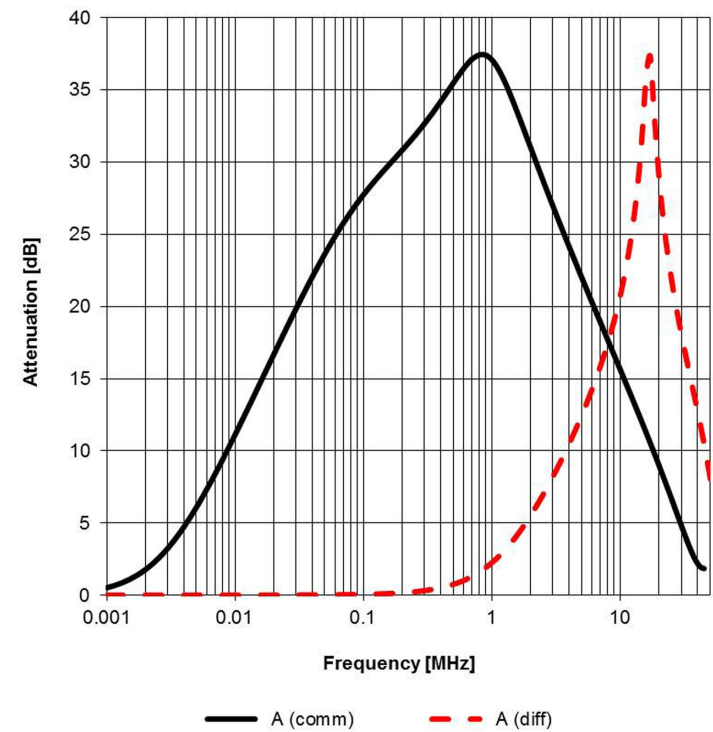



Product specific:
