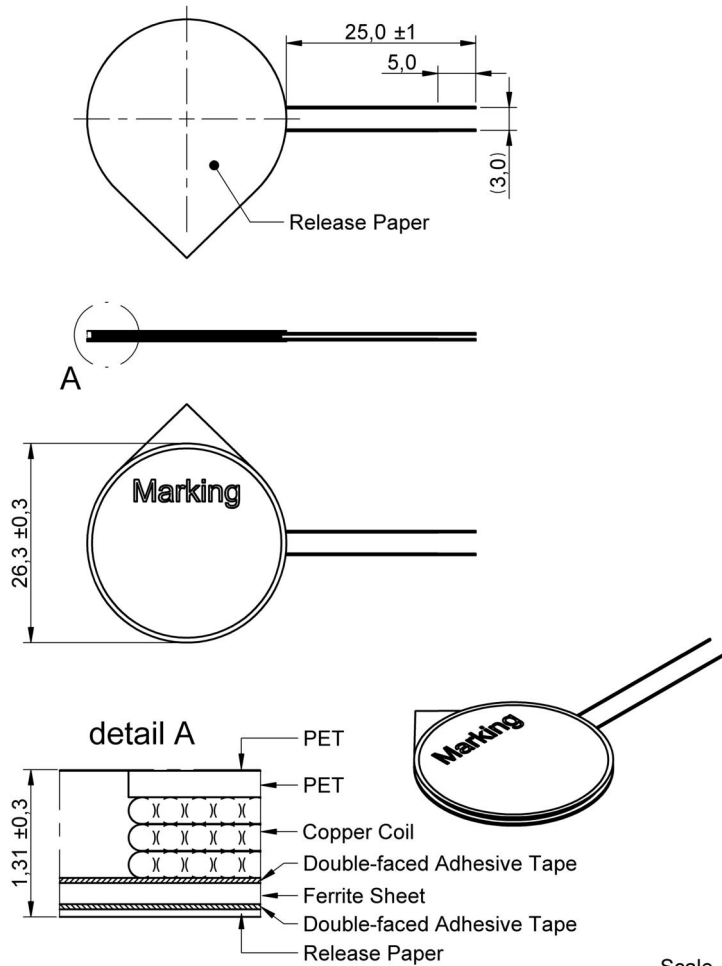
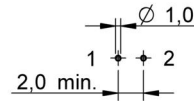

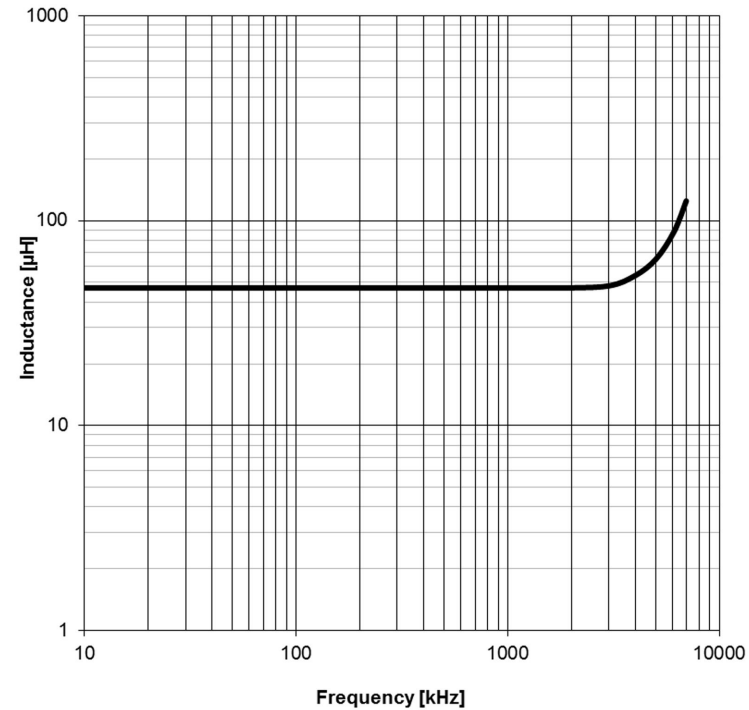

**F2 Typical Inductance vs. Frequency Characteristics:**

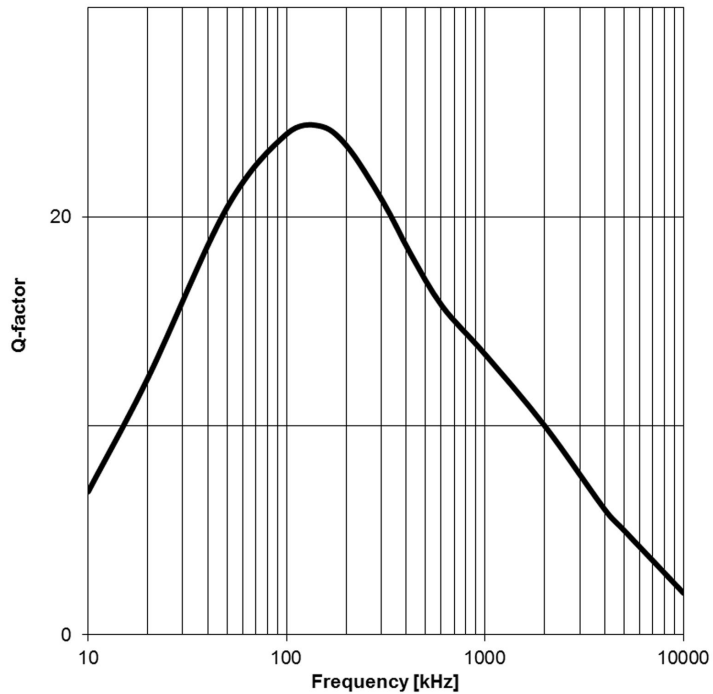

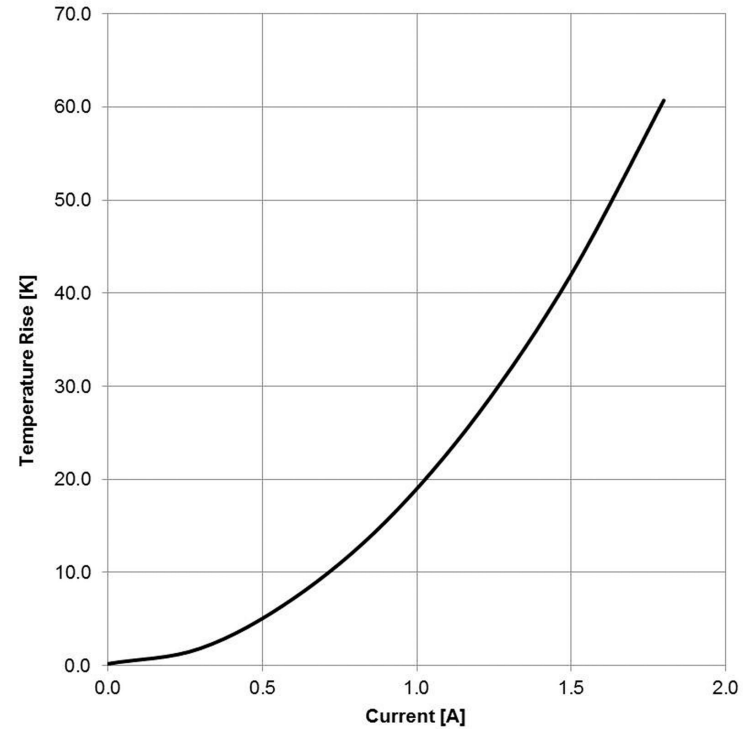



### Product specific:
