Typical Insertion Loss:



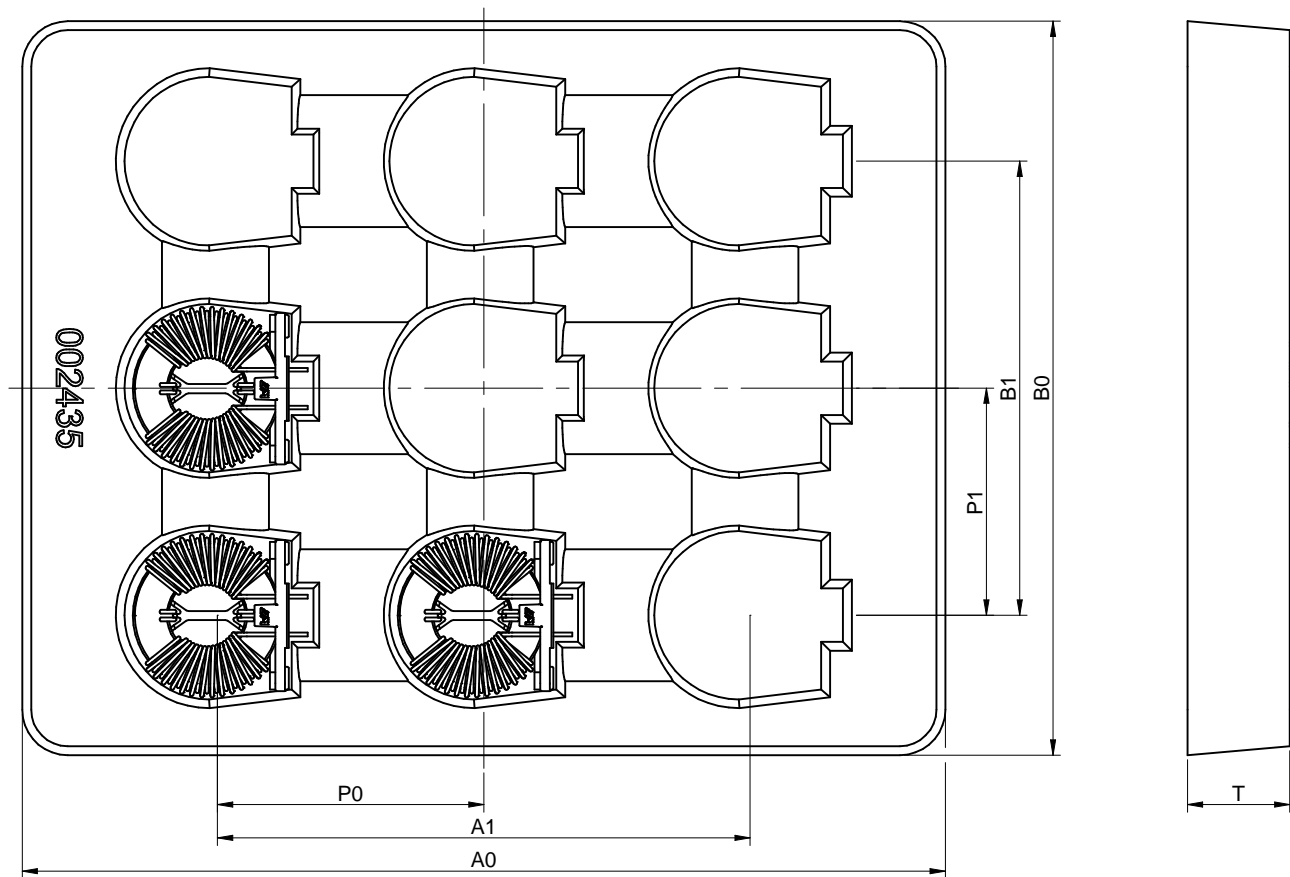
