

TPS54719EVM-152, 7-A, SWIFT™ Regulator Evaluation Module

The TPS54719EVM-152 evaluation module allows designers to evaluate the TPS54719 dc/dc converter. This user's guide contains a description of the test setup and results and provides the schematic, board art, and bill of materials of the EVM.

1 Introduction

This user's guide contains background information for the TPS54719 as well as support documentation for the TPS54719EVM-152 evaluation module (also called PWR152). Also included are the performance specifications, the schematic, and the bill of materials for the TPS54719EVM-152.

1.1 Background

The TPS54719 dc/dc converter is designed to provide up to a 7-A output from an input voltage source of 2.95 V to 6 V. Rated input voltage and output current range for the evaluation module are given in Table 1. This evaluation module is designed to demonstrate the small, printed-circuit-board areas that can be achieved when designing with the TPS54719 regulator. The switching frequency is externally set at a nominal 500 kHz. The high-side and low-side MOSFETs are incorporated inside the TPS54719 package along with the gate drive circuitry. The low, drain-to-source on-resistance of the MOSFETs allows the TPS54719 to achieve high efficiencies and helps keep the junction temperature low at high output currents. The compensation components are external to the integrated circuit (IC), and an external divider allows for an adjustable output voltage. Additionally, the TPS54719 provides adjustable slow start and undervoltage lockout inputs. The absolute maximum input voltage is 7 V for the TPS54719EVM-152.

1.2 Performance Specification Summary

A summary of the TPS54719EVM-152 performance specifications is provided in Table 2. Specifications are given for an input voltage of $V_{IN} = 5$ V and an output voltage of 1.8 V, unless otherwise specified. The TPS54719EVM-152 is designed and tested for $V_{IN} = 3$ V to 6 V. The ambient temperature is 25°C for all measurements, unless otherwise noted.

1.3 Modifications

These evaluation modules are designed to provide access to the features of the TPS54719. Some modifications can be made to this module.

1.3.1 Output Voltage Set Point

The voltage divider R9 and R10 is used to set the output voltage. To change the output voltage of the EVM, it is necessary to change the value of resistor R9. Changing the value of R9 can change the output voltage above 0.6 V. The value of R9 for a specific output voltage can be calculated using Equation 1. Use 10 k Ω for R10.

Table 3 lists the R9 and R10 values for some common output voltages. Note that V_{IN} must be in a range so that the minimum on-time is greater than 80 ns, and the maximum duty cycle is less than 92%. The values given in Table 3 are standard values, not the exact value calculated using Equation 1.

1.3.2 Slow-Start Time

The slow-start time can be adjusted by changing the value of C7. Use Equation 2 to calculate the required value of C7 for a desired slow-start time

C7 is set to 0.01 μ F on the EVM for a default slow-start time of 2.5 msec.

1.3.3 Adjustable UVLO

The undervoltage lockout (UVLO) can be adjusted externally using R1 and R2. The EVM is set for a start voltage of 2.794 V and a stop voltage of 2.595 V using R1 = 14.3 k Ω and R2 = 11.5 k Ω . Use Equation 3 and Equation 4 to calculate required resistor values for different start and stop voltages.

2 Test Setup and Results

This section describes how to properly connect, set up, and use the TPS54719EVM-152 evaluation module. The section also includes test results typical for the evaluation module and covers efficiency, output voltage regulation, load transients, loop response, output ripple, input ripple, and start-up.

2.1 Input/Output Connections

The TPS54719EVM-152 is provided with input/output connectors and test points as shown in Table 4. A power supply capable of supplying 5 A must be connected to J1 through a pair of 20 AWG wires. The load must be connected to J3 through a pair of 20 AWG wires. The maximum load current capability must be at least 7 A to use the full capability of this EVM. Wire lengths must be minimized to reduce losses in the wires. Test-point TP1 provides a place to monitor the V_{IN} input voltages with TP2 providing a convenient ground reference. TP8 is used to monitor the output voltage with TP9 as the ground reference.

2.2 Efficiency

The efficiency of this EVM peaks at a load current of about 0.5 A – 1 A and then decreases as the load current increases towards full load. Figure 1 shows the efficiency for the TPS54719EVM-152 at an ambient temperature of 25° C.






Figure 2 shows the efficiency for the TPS54719EVM-152 in a semi-log format to emphasize the efficiency at lower output currents. The ambient temperature is 25°C.




Figure 2. TPS54719EVM-152 Low Current Efficiency

The efficiency may be lower at higher ambient temperatures, due to temperature variation in the drain-tosource resistance of the internal MOSFET.

2.3 Output Voltage Load Regulation




Figure 3. TPS54719EVM-152 Load Regulation

Figure 3 shows the load regulation for the TPS54719EVM-152.

Measurements are given for an ambient temperature of 25°C.





Figure 4. TPS54719EVM-152 Line Regulation

Figure 4 shows the line regulation for the TPS54719EVM-152.

2.5 Load Transients

Figure 5 shows the TPS54719EVM-152 response to load transients. The current step is from 25% to 75% of maximum rated load at 5 V input. Total peak-to-peak voltage variation is as shown, including ripple and noise on the output.

2.6 Loop Characteristics




Figure 6. TPS54719EVM-152 Loop Response

Figure 6 shows the TPS54719EVM-152 loop-response characteristics. Gain and phase plots are shown for V_{IN} voltage of 5 V. Load current for the measurement is 3.5 A.



2.7 Output Voltage Ripple

Figure 7 shows the TPS54719EVM-152 output voltage ripple. The output current is the rated full load of 7 A and $V_{IN} = 5$ V. The ripple voltage is measured directly across the output capacitors.





Figure 8 shows the TPS54719EVM-152 input voltage ripple. The output current is the rated full load of 7 A and $V_{IN} = 5$ V. The ripple voltage is measured directly across the input capacitors.








2.9 Powering Up


Figure 9 and Figure 10 show the start-up waveforms for the TPS54719EVM-152. In Figure 9, the output voltage ramps up as soon as the input voltage reaches the UVLO threshold as set by the R_1 and R_2 resistor divider network. In Figure 10, the input voltage is initially applied and the output is inhibited by using a jumper at JP1 to tie EN to GND. When the jumper is removed, EN is released. When the EN voltage reaches the enable-threshold voltage, the start-up sequence begins and the output voltage ramps up to the externally set value of 1.8 V. The input voltage for these plots is 5 V and the load is 7 Ω .

Figure 10. TPS54719EVM-152 Start-Up Relative to Enable





2.10 Powering Down




Figure 12. TPS54719EVM-152 Shutdown Relative to EN

Figure 11 and Figure 12 show the shut-down waveforms for the TPS54719EVM-152. In Figure 11, the output voltage ramps down as soon as the input voltage falls below the UVLO stop threshold as set by the R1 and R2 resistor divider network. In Figure 12, the output is inhibited by using a jumper at JP1 to tie EN to GND. The input voltage for these plots is 5 V and the load is 7 Ω .

3 Board Layout

This section provides a description of the TPS54719EVM-152, board layout, and layer illustrations.

3.1 Layout




Figure 13. TPS54719EVM-152 Top-Side Assembly

Figure 13 through Figure 17 shows the board layout for the TPS54719EVM-152. The top-side layer of the EVM is laid out in a manner typical of a user application. The top, bottom, and internal layers are 2-oz. copper.

The top layer contains the main power traces for V_{IN} , V_{OUT} , and VPHASE. Also on the top layer are connections for the remaining pins of the TPS54719 and a large area filled with ground. The bottom and internal layers contain ground planes only. The top-side ground areas are connected to the bottom and internal ground planes with multiple vias placed around the board including four vias directly under the TPS54719 device to provide a thermal path from the top-side ground area to the bottom-side and internal ground planes.

The input decoupling capacitors (C1, C2 and C3) and bootstrap capacitor (C8) are all located as close to the IC as possible. In addition, the voltage set-point resistor divider components are also kept close to the IC. The voltage divider network ties to the output voltage at the point of regulation, the copper V_{OUT} trace near the output connector J3. For the TPS54719, an additional input bulk capacitor may be required, depending on the EVM connection to the input supply.






Figure 14. TPS54719EVM-152 Top-Side Layout










Figure 16. TPS54719EVM-152 Internal Layer 2 Layout




Figure 17. TPS54719EVM-152 Bottom-Side Layout




Figure 18. TPS54719EVM-152 Schematic
