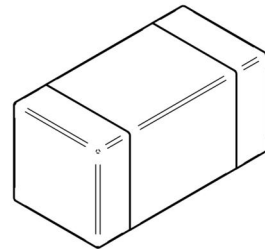
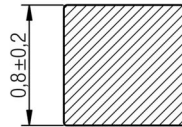

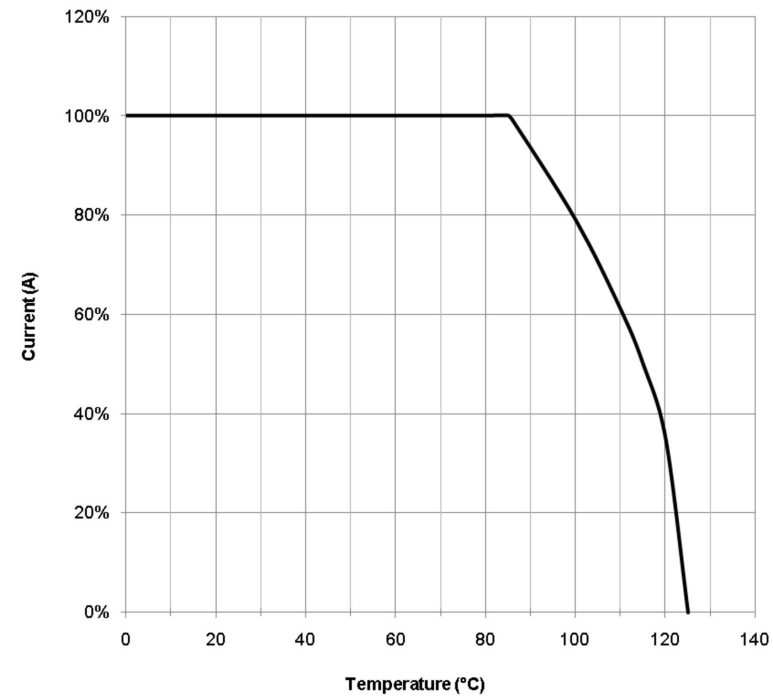


### F Typical Impedance Characteristics:
