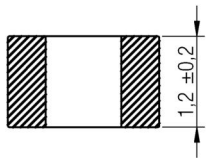
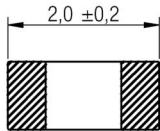
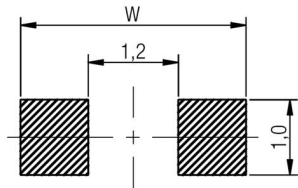

C Schematic:

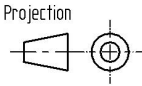

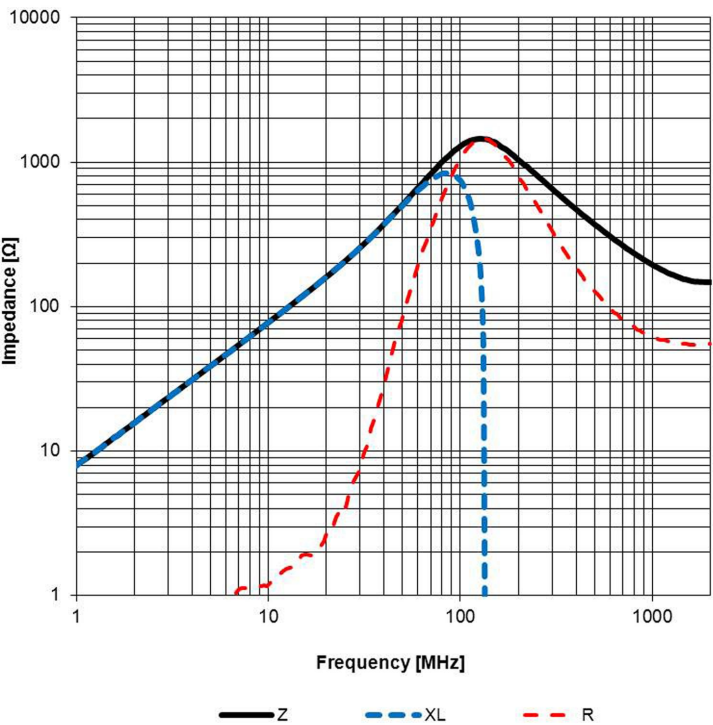
