### Description

The CPC2014N is a miniature device with two independent 1-Form-A solid state relays in an 8-Pin SOIC package that employs optically coupled MOSFET technology to provide 1500V<sub>rms</sub> of input/output isolation.

Optically coupled outputs that use the patented OptoMOS architecture are controlled by a highly efficient GaAIAs infrared LED.

The CPC2014N uses IXYS Integrated Circuits Division's state of the art, double-molded vertical construction packaging to produce one of the world's smallest relays. The CPC2014N offers substantial board space savings over the competitor's larger 8-Pin SOIC relay.

IXYS Integrated Circuits Division recommends the use of no-clean flux formulations. However, board washing to remove flux residue is acceptable. Since IXYS Integrated Circuits Division employs the use of silicone coating as an optical waveguide in many of its optically isolated products, the use of a short drying bake could be necessary if a wash is used after solder reflow processes. Chlorine- or Fluorine-based solvents or fluxes should not be used. Cleaning methods that employ ultrasonic energy should not be used.
