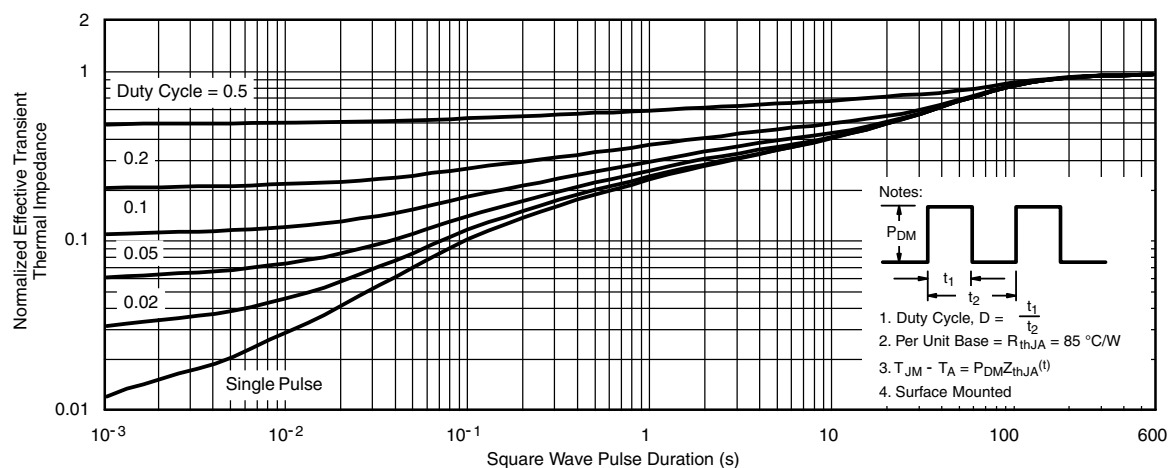

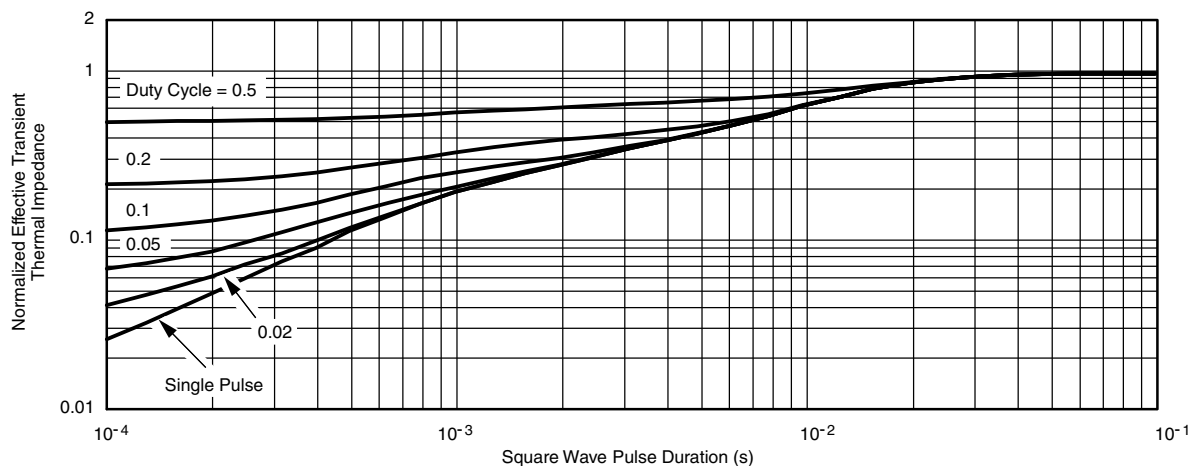

Normalized Thermal Transient Impedance, Junction-to-Case

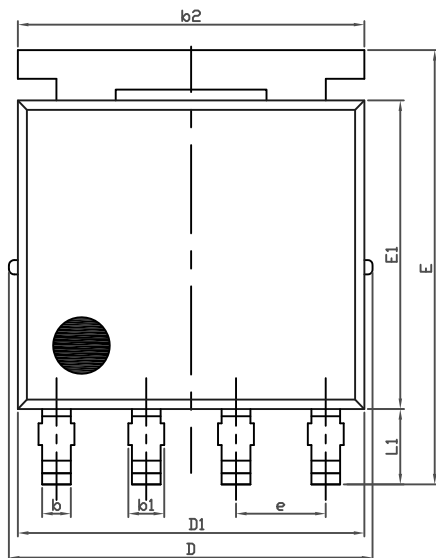

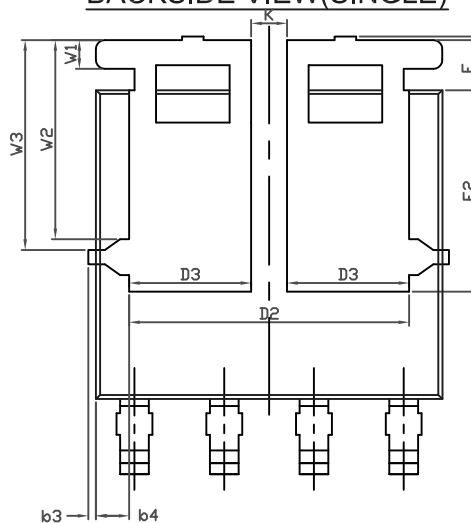

BACKSIDE VIEW(DUAL)



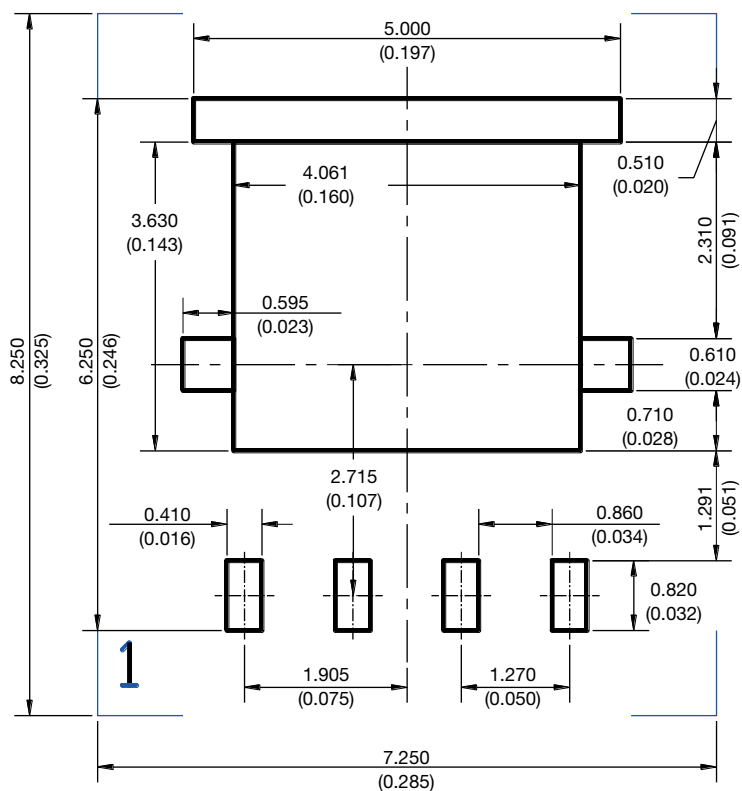
