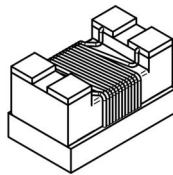
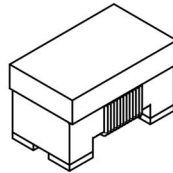

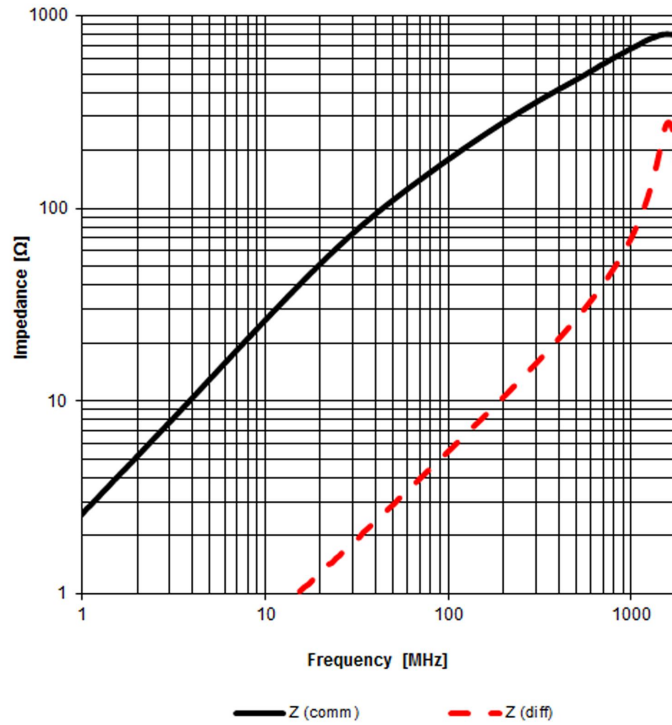

Common Mode

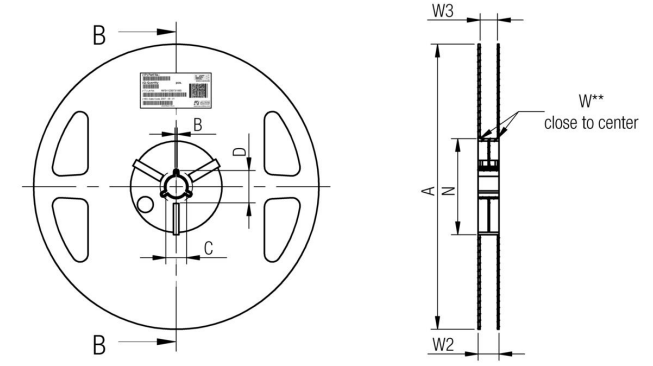


Differential Mode
