Schematic:



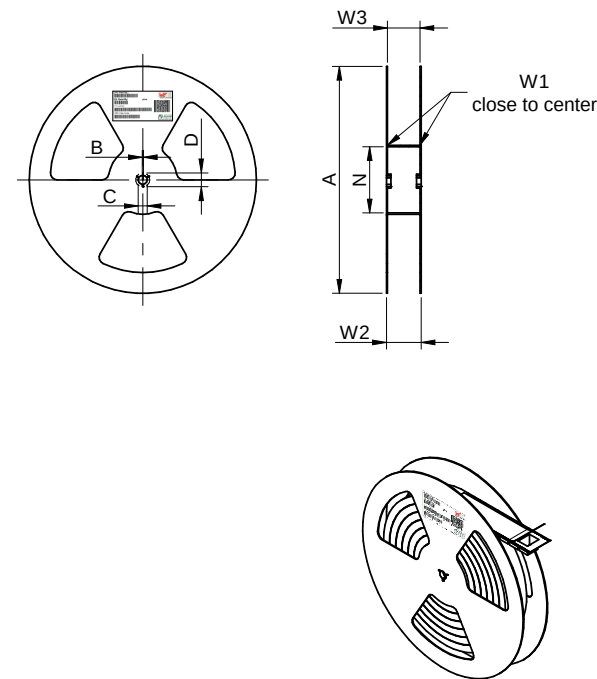
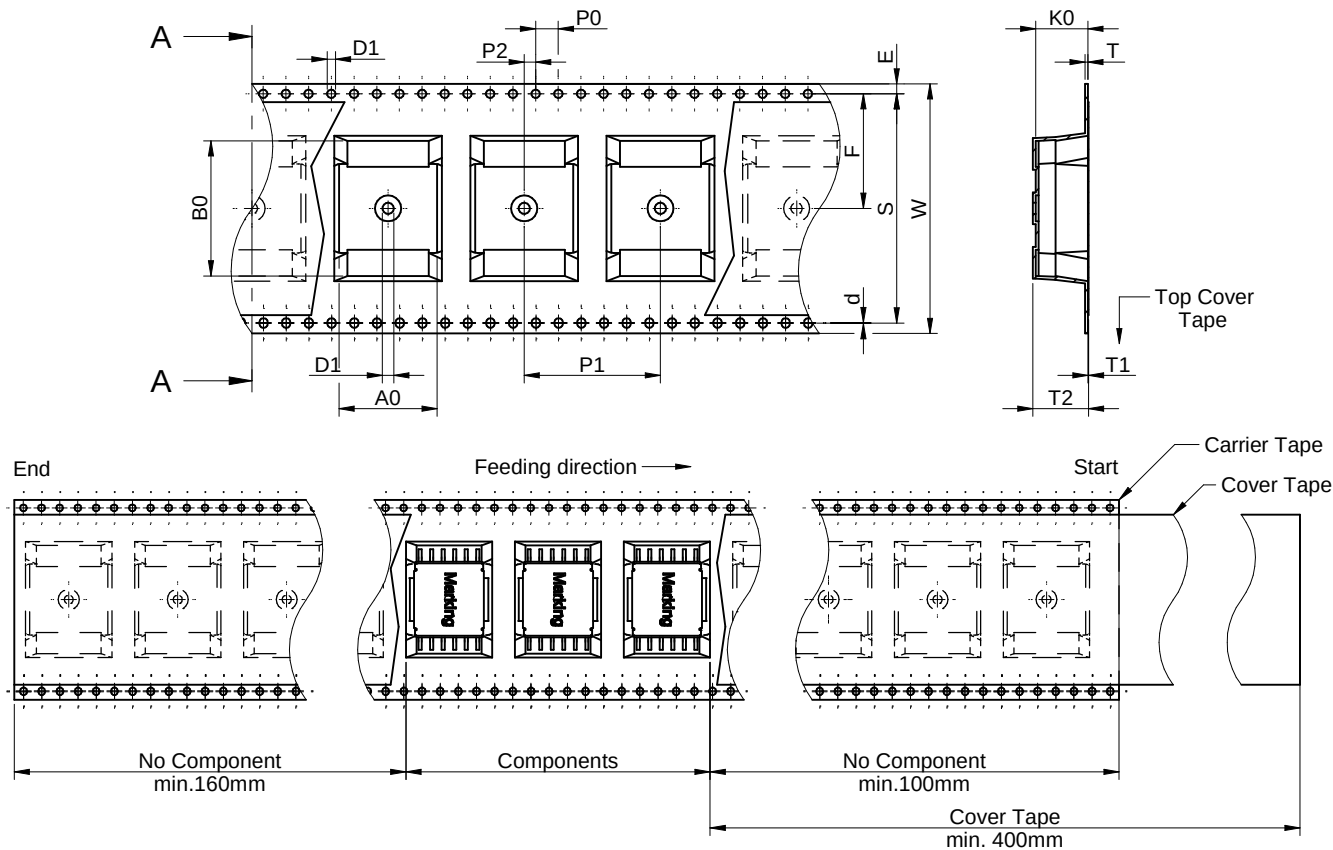
