Typical Impedance Characteristics:



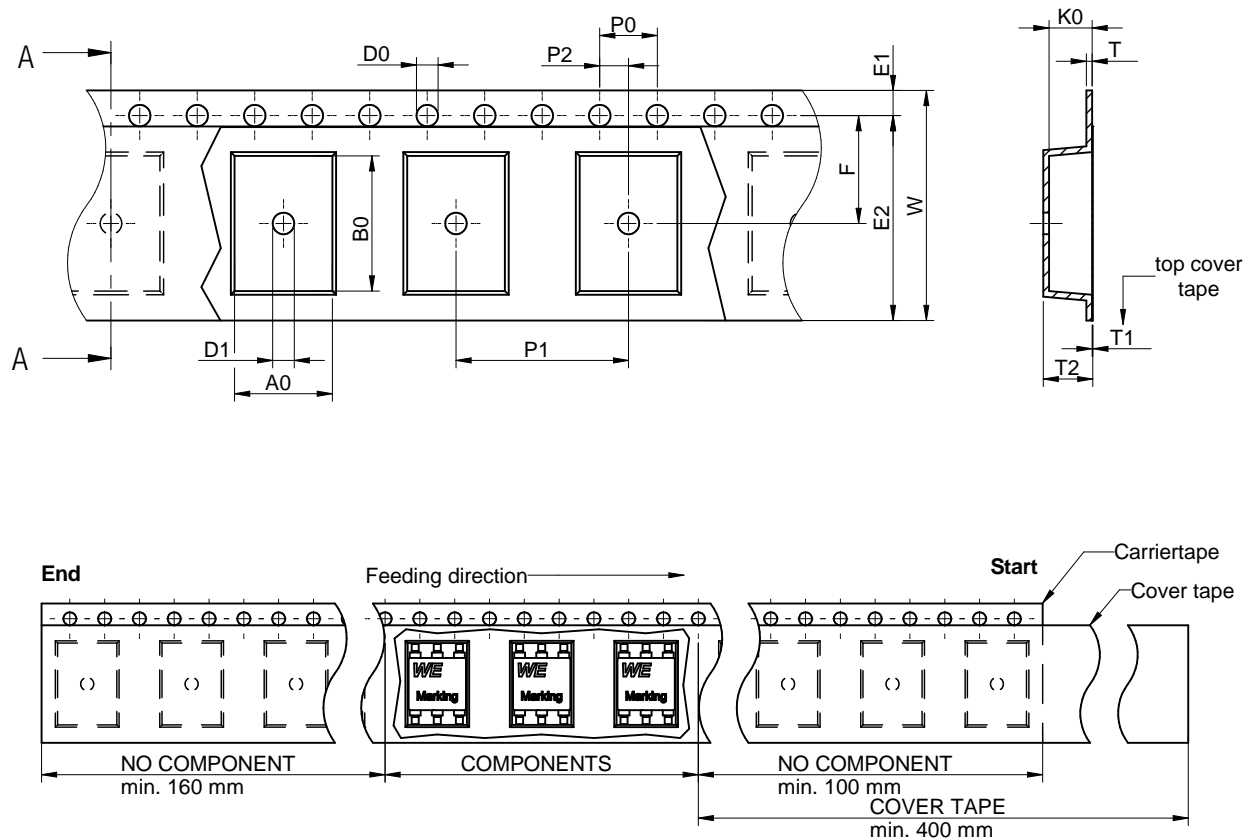
