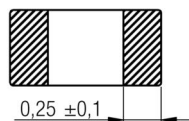

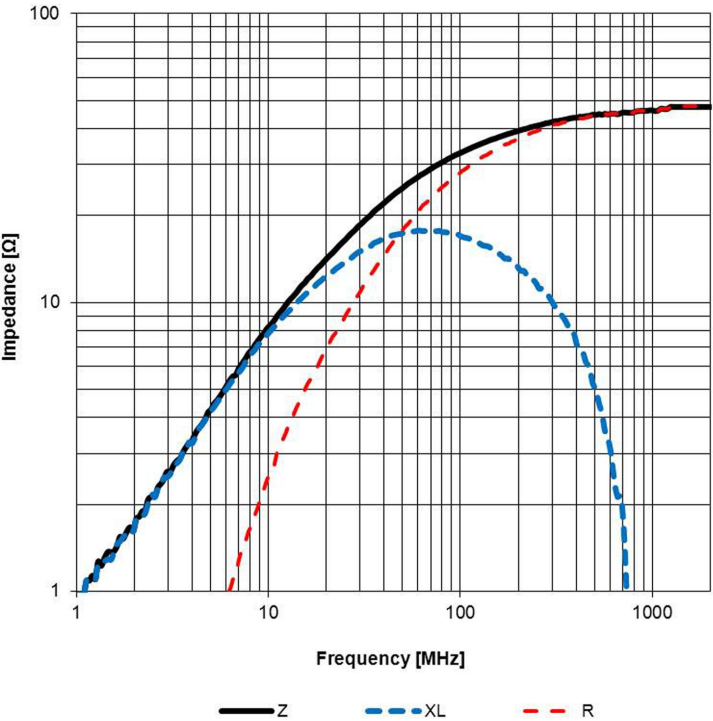

- The solder profile has to be complied with according to the technical reflow soldering specification, otherwise no warranty will be sustained.
