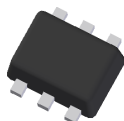

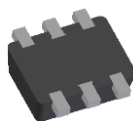

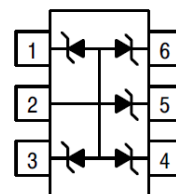

Bottom View



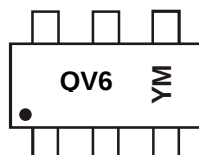

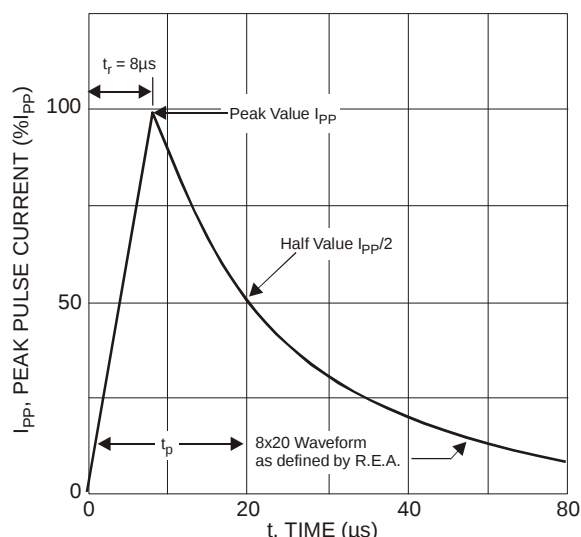


Figure 1 Pulse Waveform

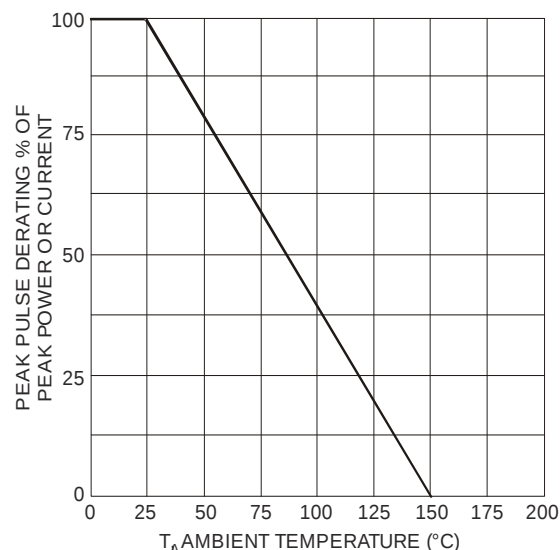


Figure 2 Power Dissipation vs. Ambient Temperature

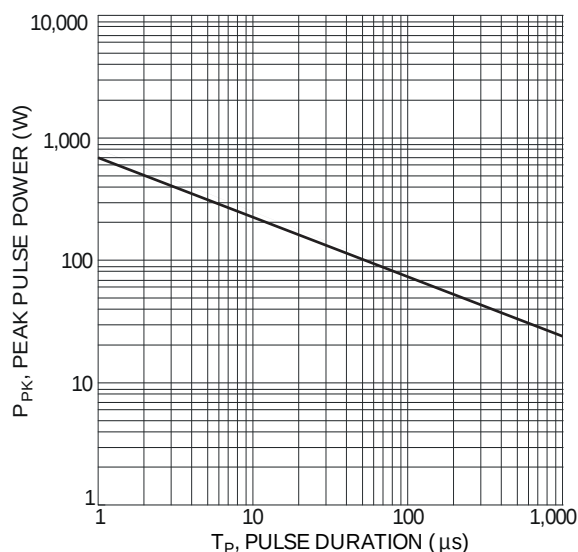


Figure 3 Peak Pulse Power vs. Pulse Duration

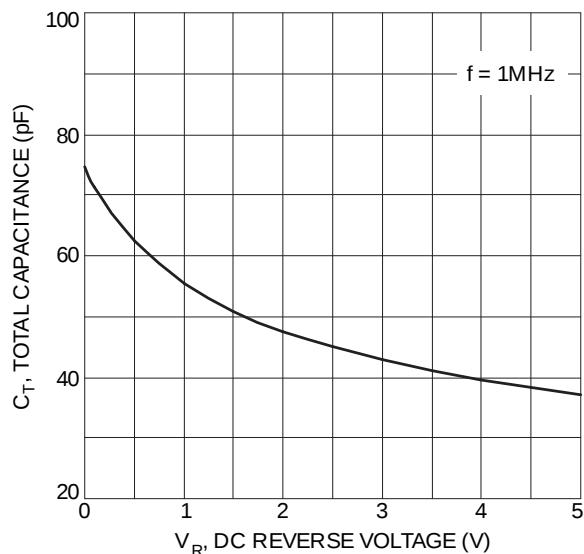
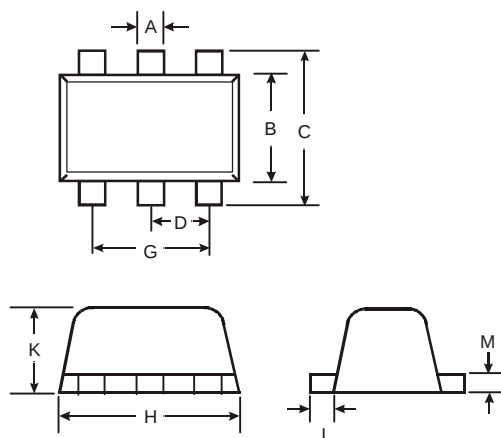


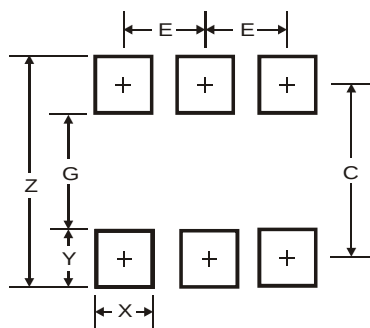
Figure 4 Total Capacitance vs. Reverse Voltage
