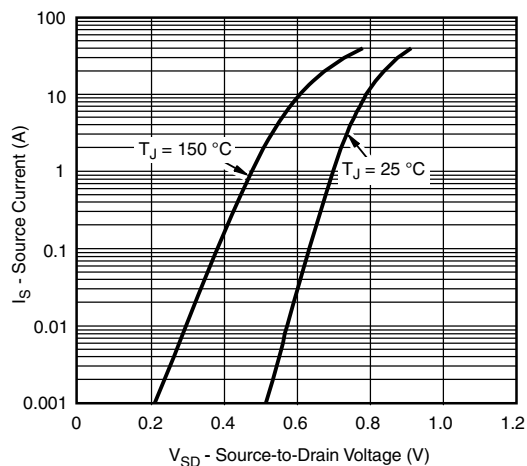

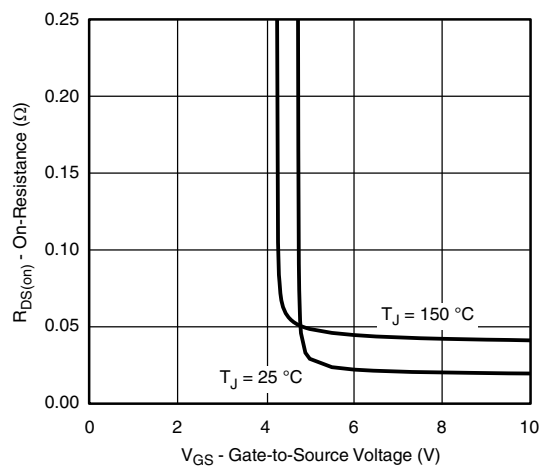




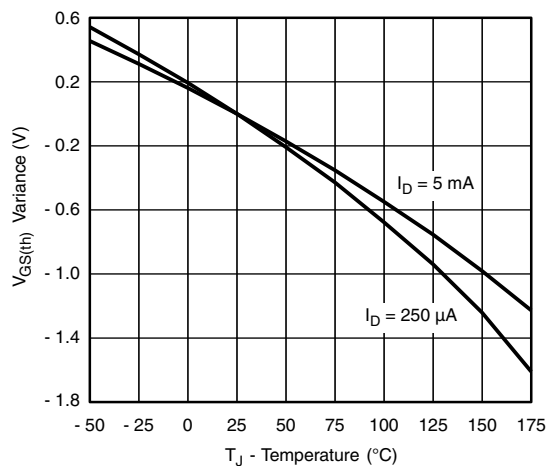

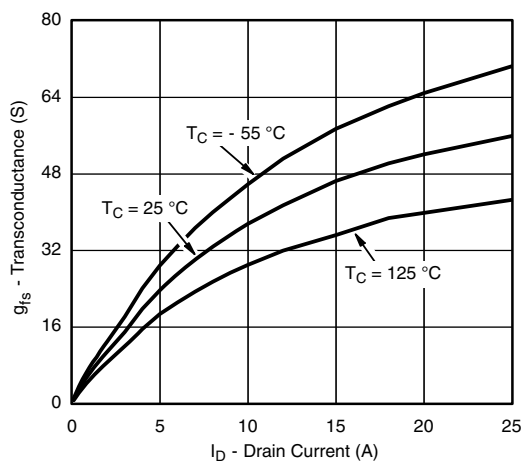
Source Drain Diode Forward Voltage



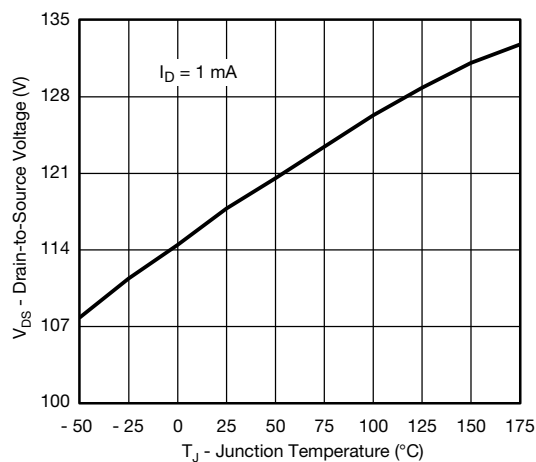
On-Resistance vs. Gate-to Source Voltage



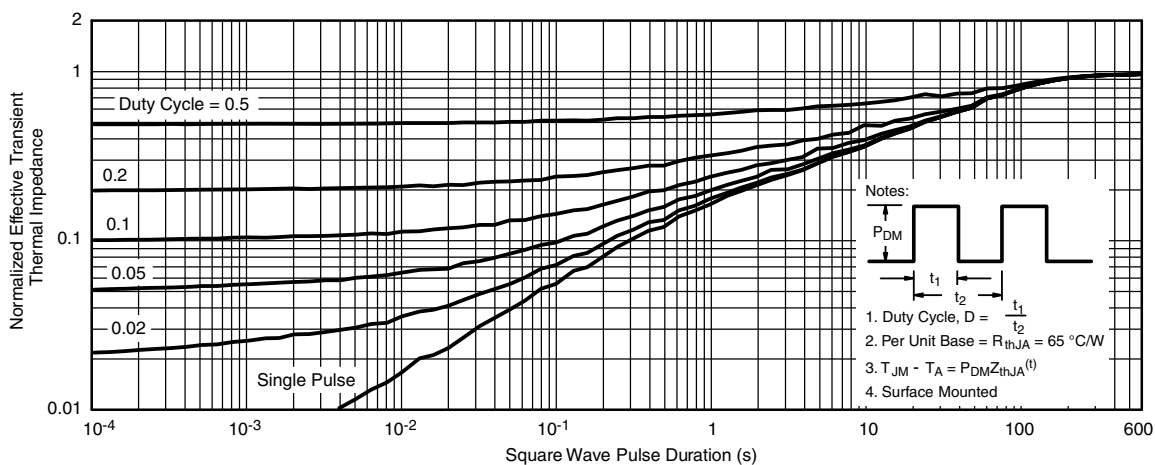
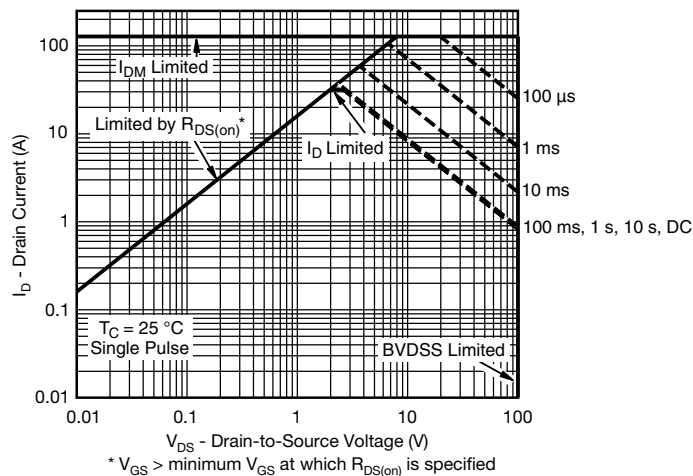

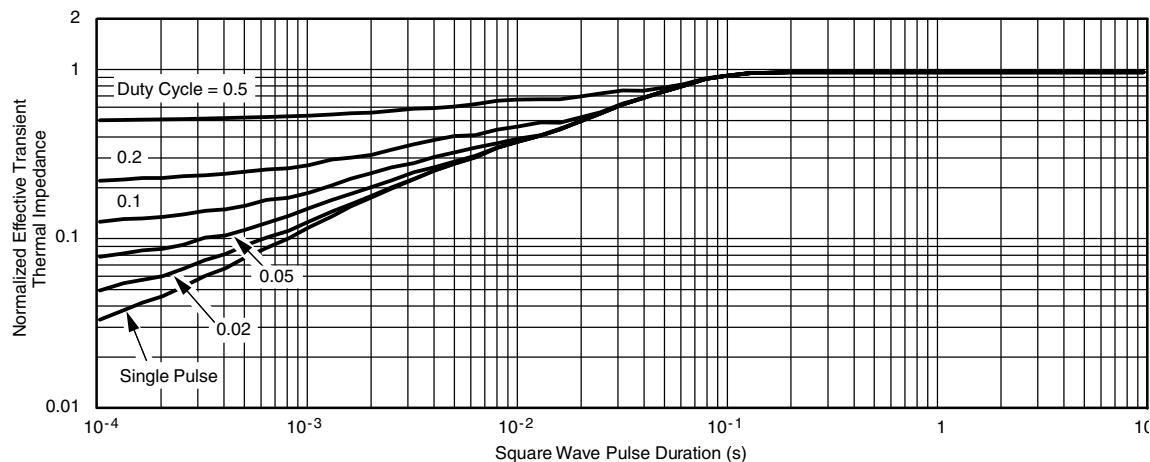


Transconductance

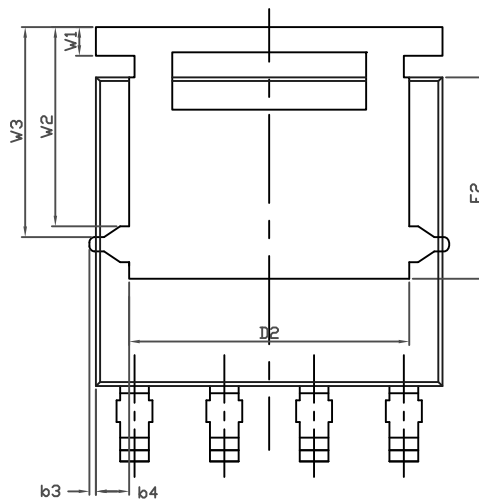
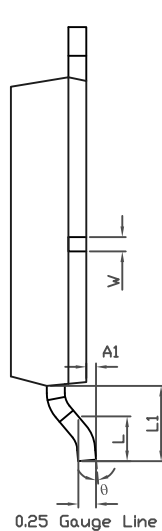

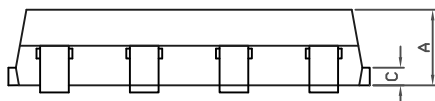
