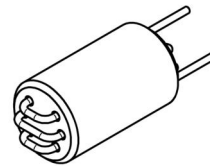
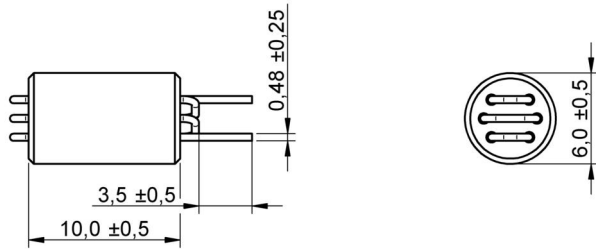

C Schematic:



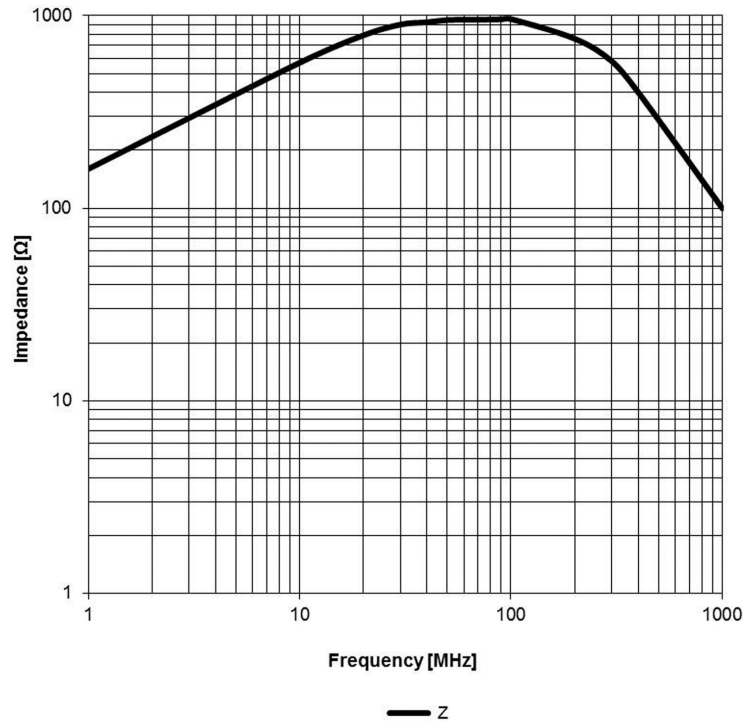
