Fiber cassette enclosure shall be designed to house, organize, manage and protect Opticom® QuickNet™ Pre-terminated Fiber Optic Cassettes and associated MTP* trunk cables, connectors, and patch cords. Enclosure shall accommodate all pre-terminated MTP* cassettes and include integral cable management and bend radius control for transition to vertical cable managers. Fiber optic enclosure shall be constructed of steel material. Molded front covers shall be removable for cabling and connector installation. Enclosure shall have multiple knockouts for a variety of trunk cable entry points.

FCE enclosures serve as a transition point for pre-terminated MTP* interconnect or backbone cable patched to active equipment in data center server cabinets or switch racks. They can be used for fast, reliable patch field creation in pre-terminated cross-connect or inter-connect

main distribution areas (MDA) or horizontal distribution areas (HDA). The enclosures provide high patch field densities with the FCE1 housing four cassettes for up to 96 fibers in 1 RU and the FCE4 housing 12 cassettes for up to 288 fibers in 4 RU. Integral cable management, bend radius control, and slack management features protect fiber optic cables, patch cords, and connectors to ensure end-to-end signal integrity.

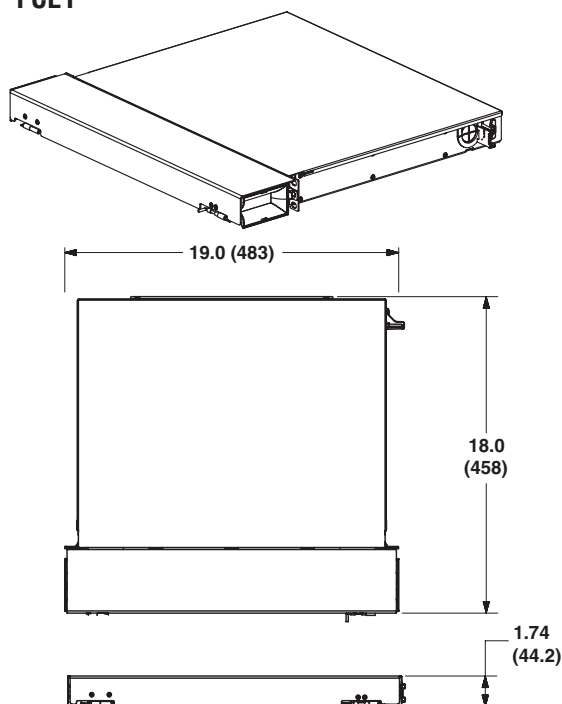

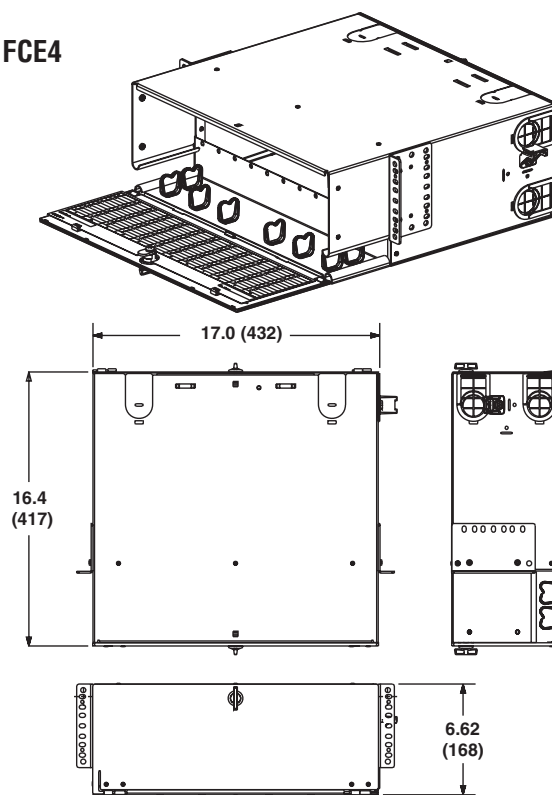
