


Figure 1. Common Drain-Source Characteristics




Figure 2. Common Drain-Source Characteristics




Figure 3. Parameter Interactions




Figure 4. Capacitance vs. Voltage




Figure 5. Normalized Drain Resistance vs. Bias Voltage




Figure 6. On Resistance vs. Drain Current




Figure 7. Output Conductance vs. Drain Current




Figure 8. Transconductance vs. Drain Current




Figure 9. Noise Voltage vs. Frequency




Figure 10. Power Dissipation vs. Ambient Temperature




Figure 11. 3-LEAD, TO-92, MOLDED, STD STRAIGHT LD (NO EOL CODE)
