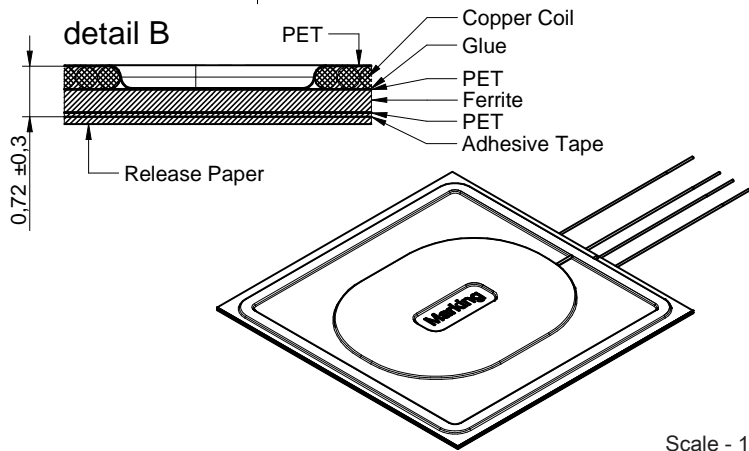
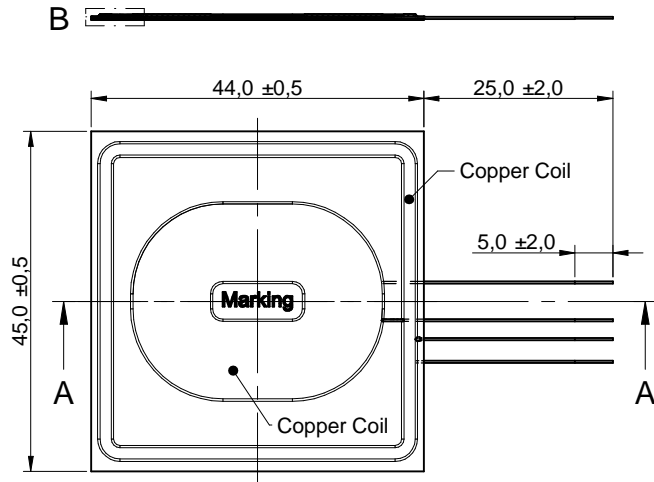

sectional drawing A-A

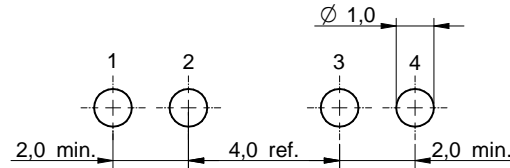

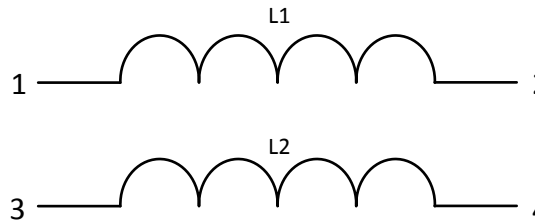

### Typical Inductance vs. Current Characteristics:



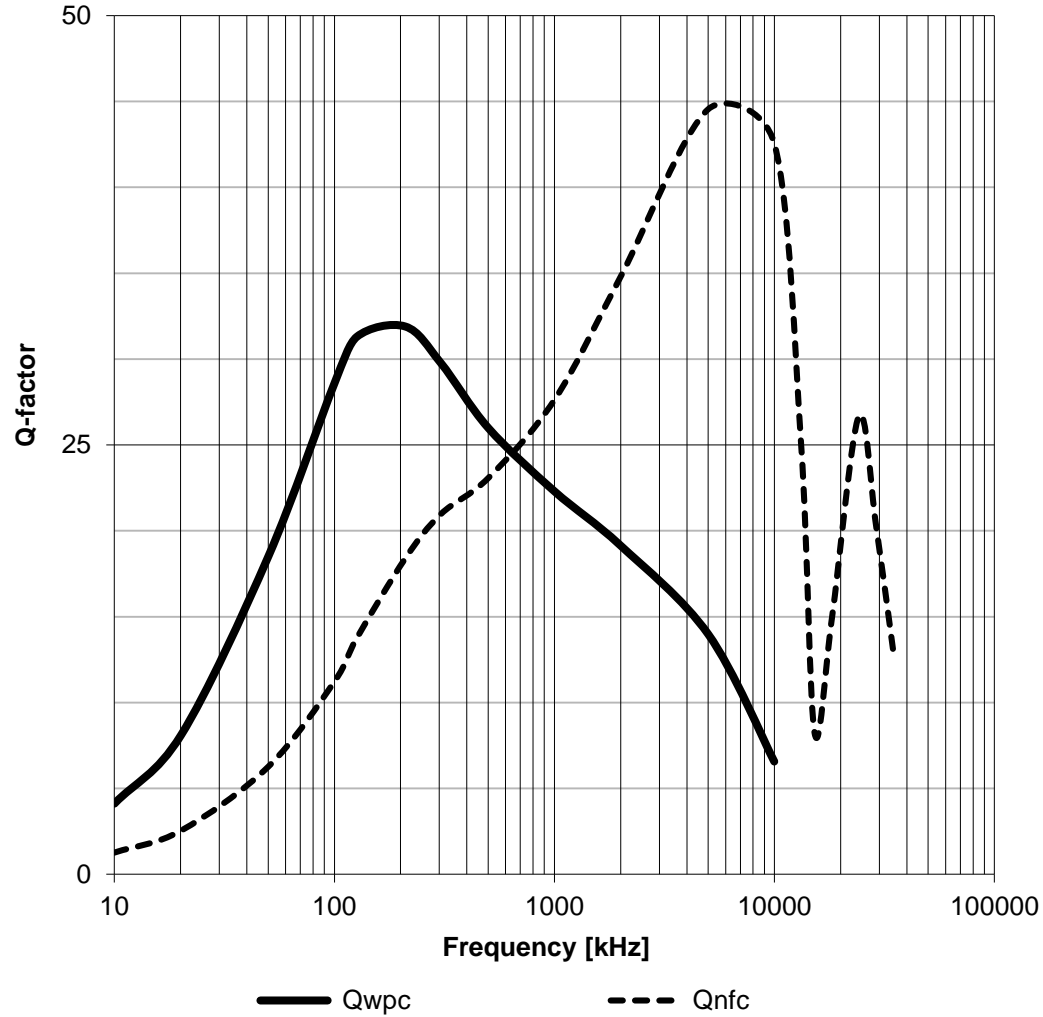
### Typical Inductance vs. Frequency Characteristics:



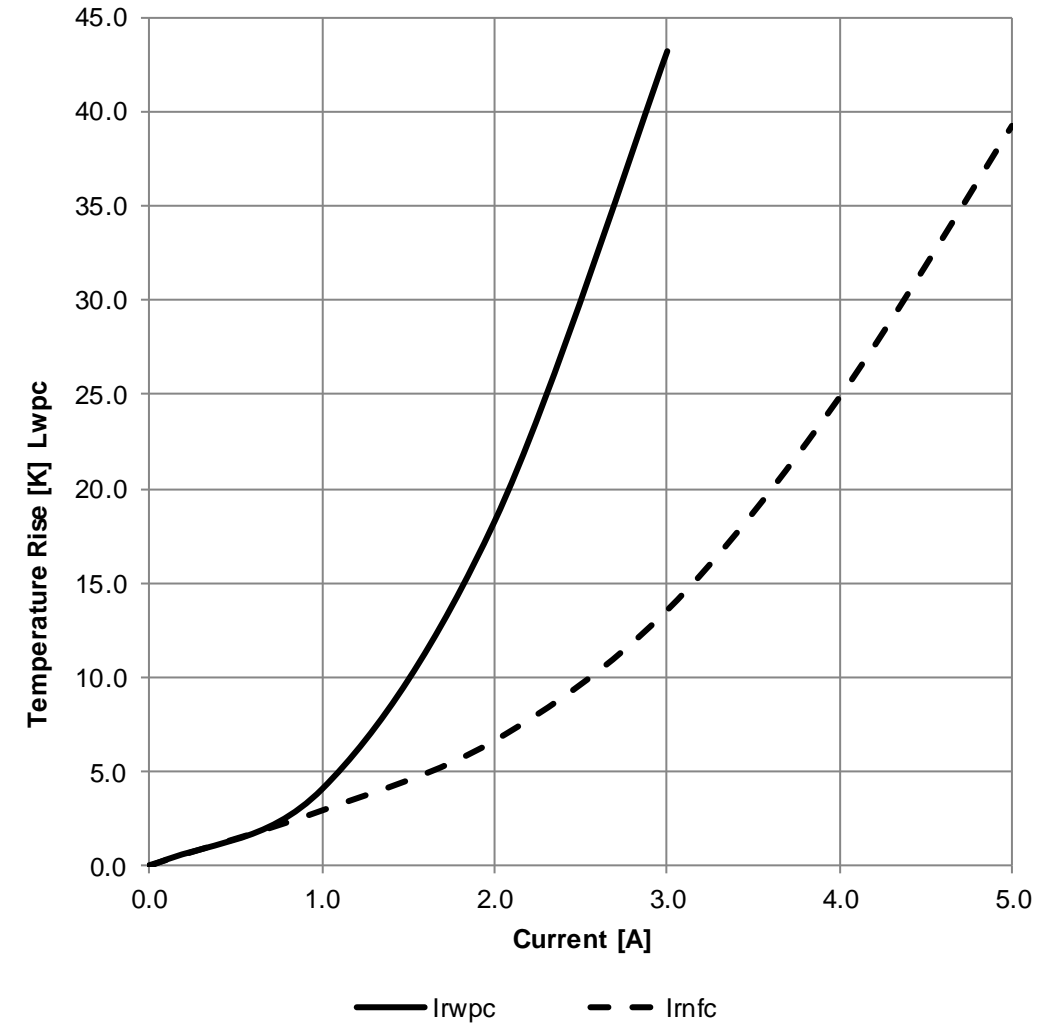


Direct mechanical impact to the product shall be prevented as the core material could flake or in the worst case could break.


