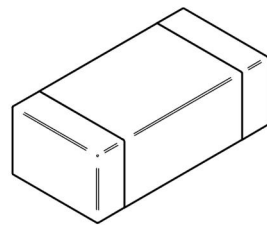

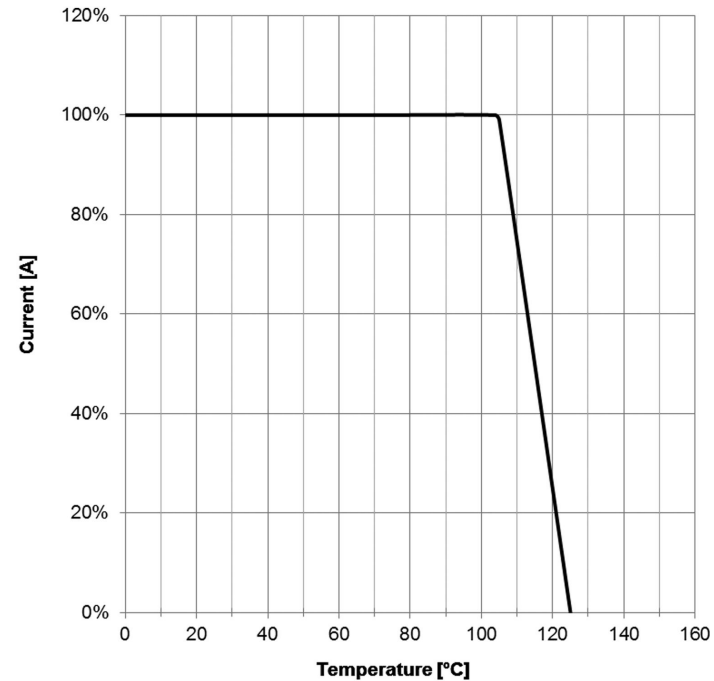


### F Typical Impedance Characteristics:

### F Derating Curve:



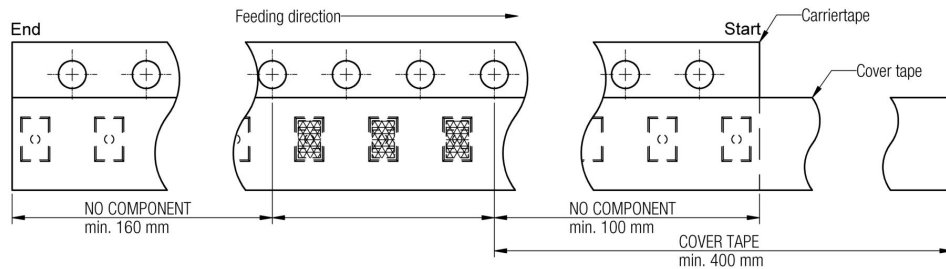
