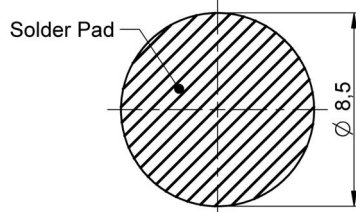


sectional drawing A-A

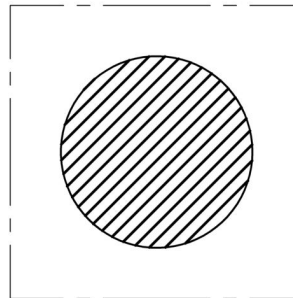
**B Recommended land pattern: [mm]**

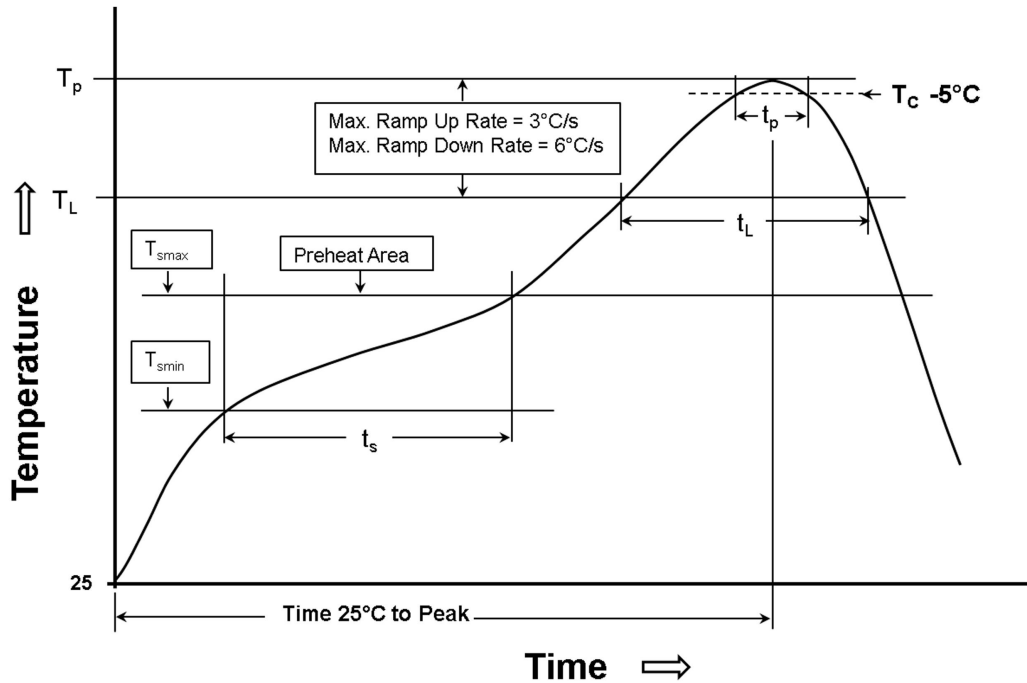




