Differential Mode

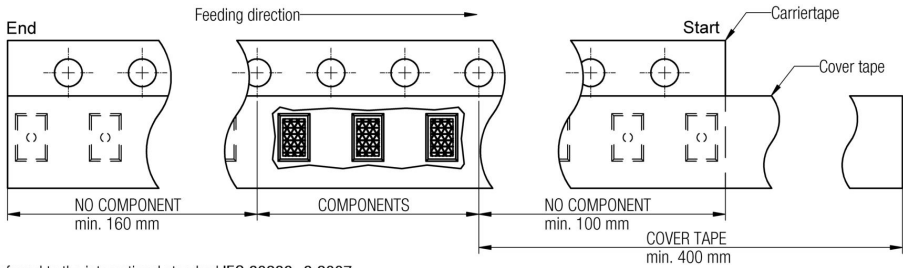
