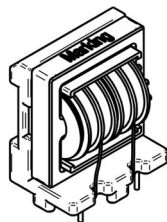

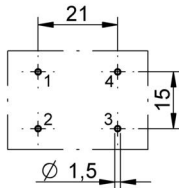

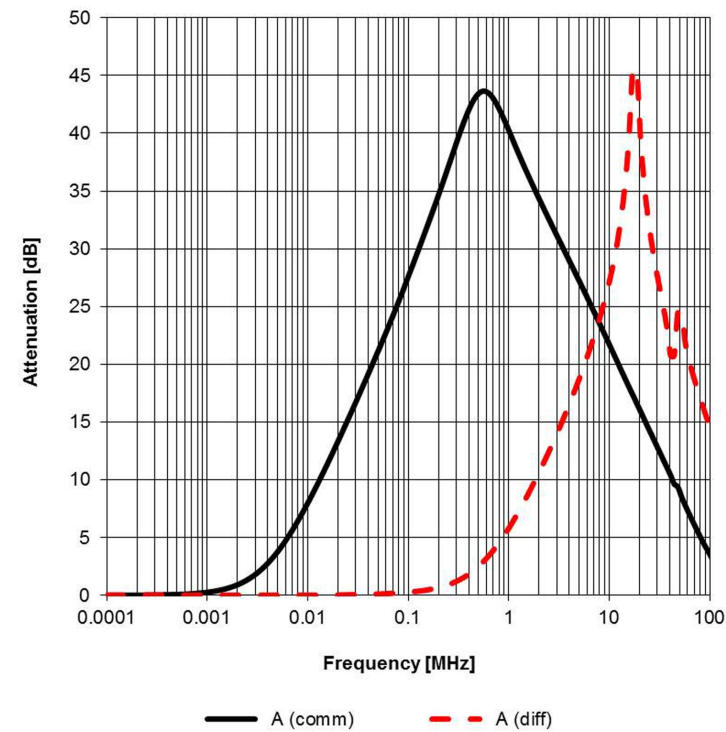

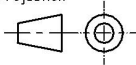
### Product specific:


