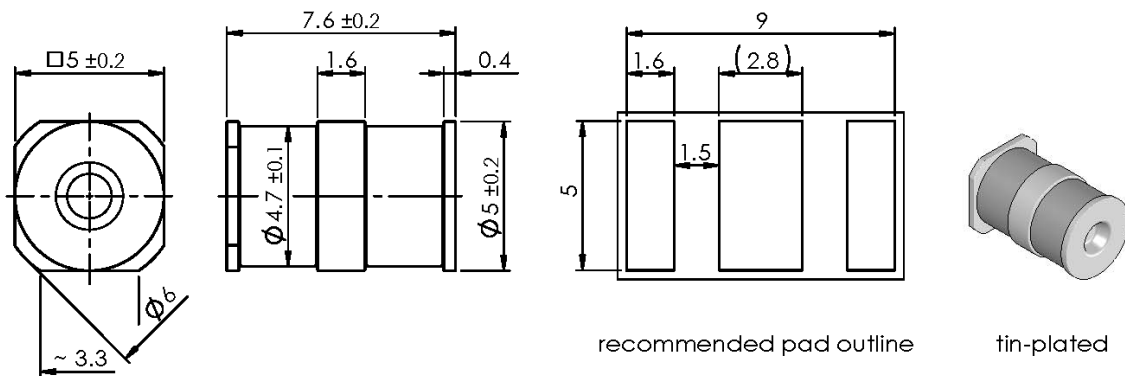

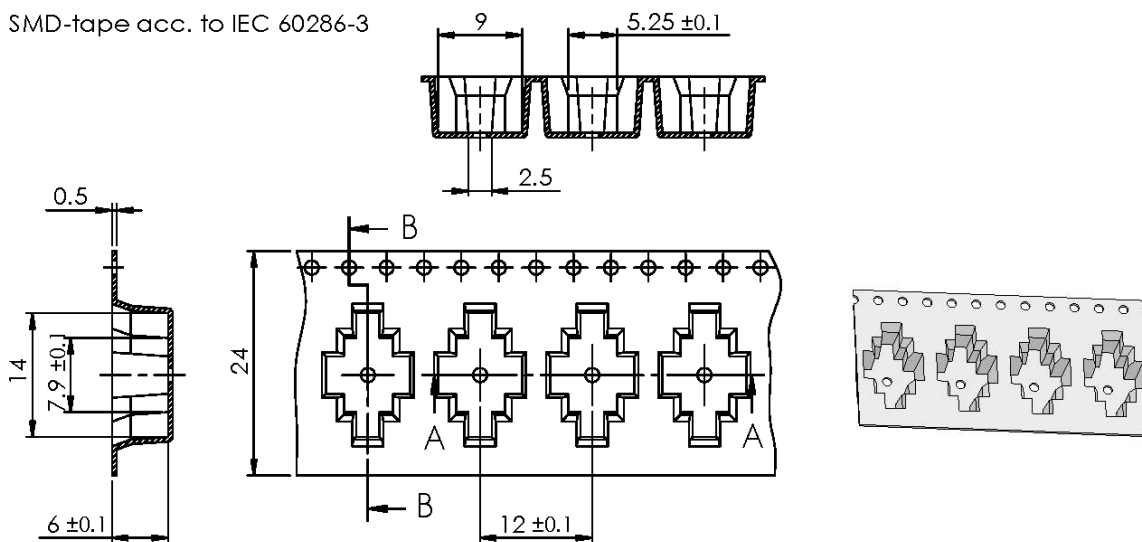
Dimensional drawing in mm
