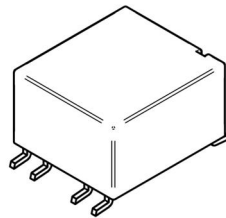
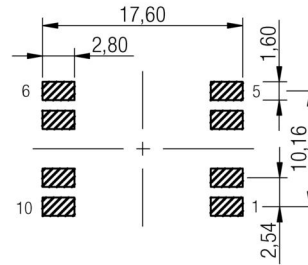

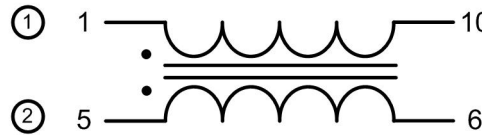

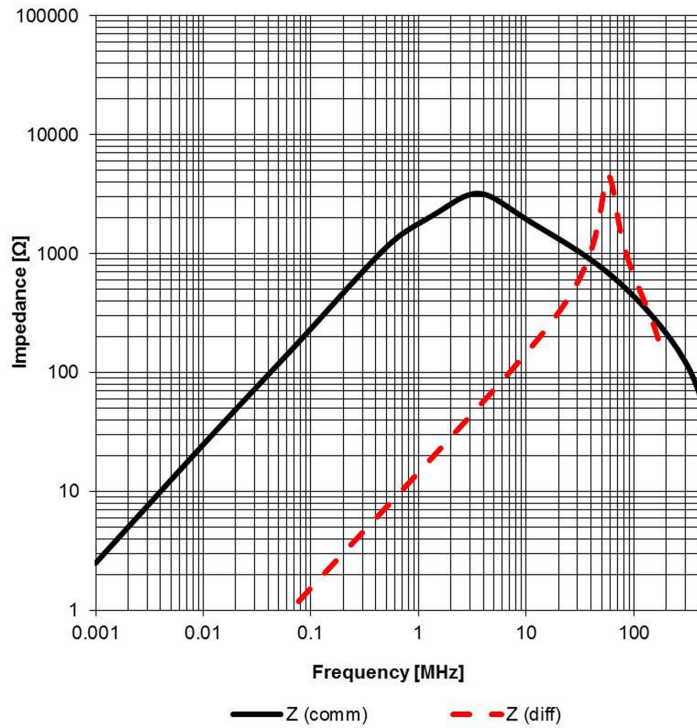

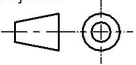

### Product specific:


