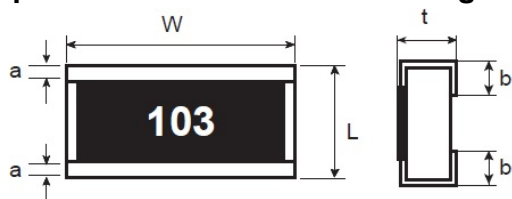

●Chip resistor dimensions and markings



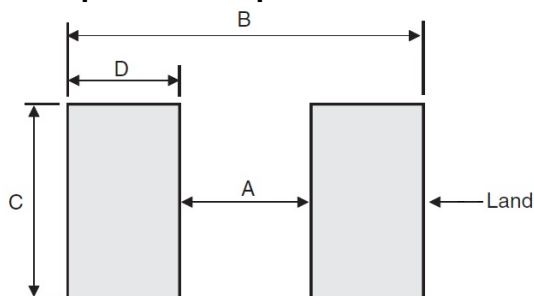

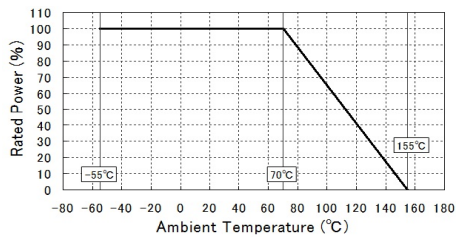
