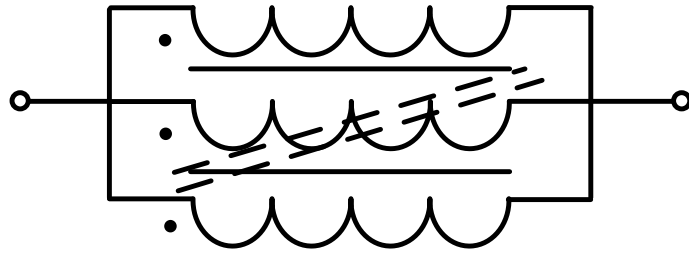

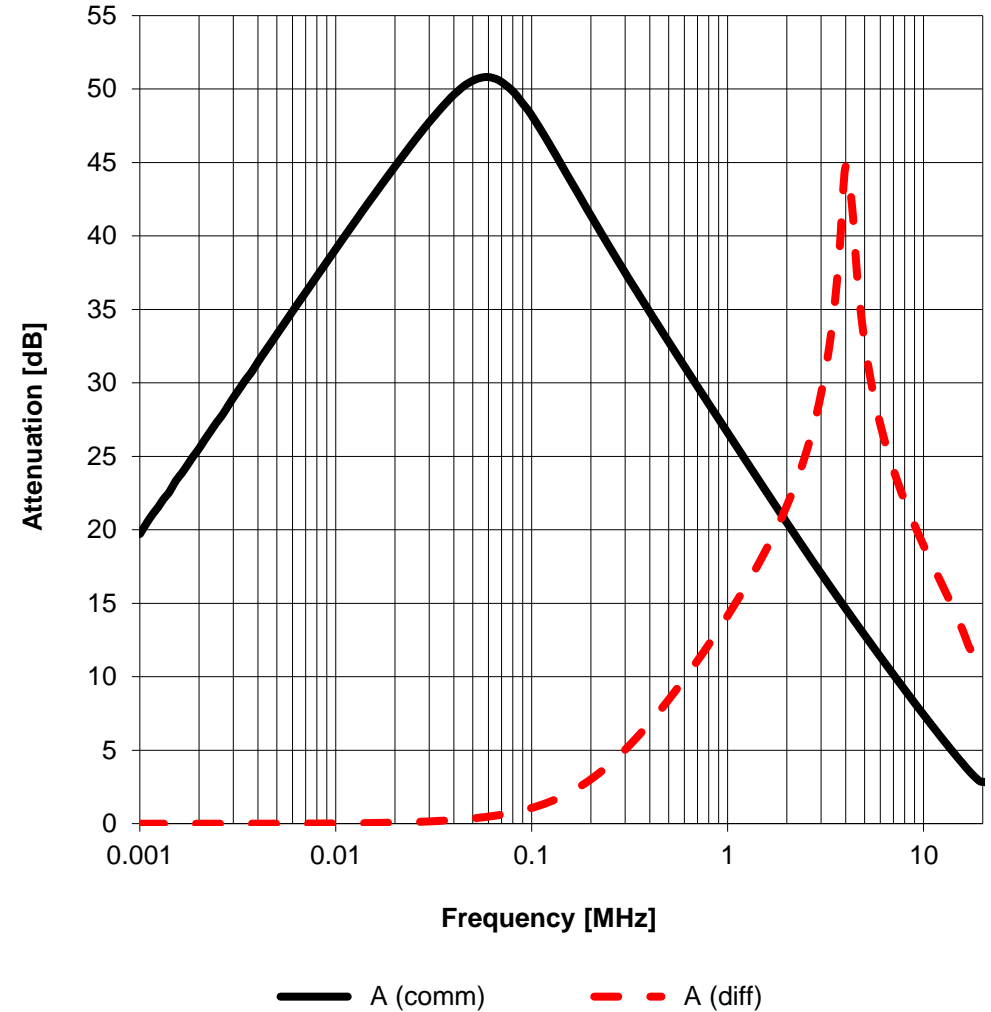
Common Mode






