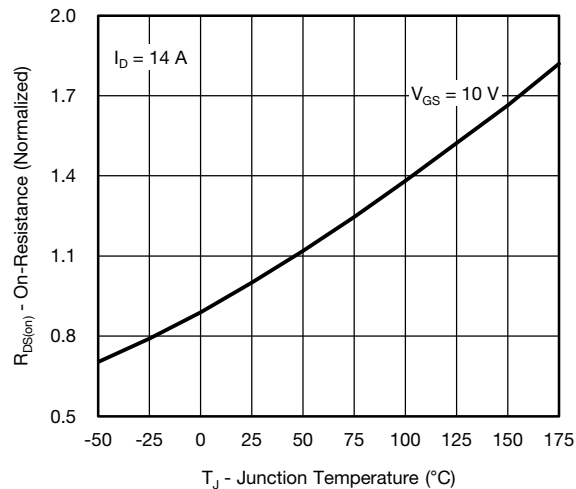
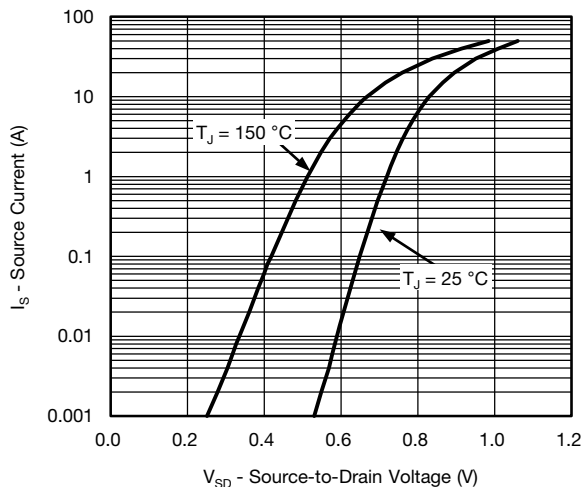
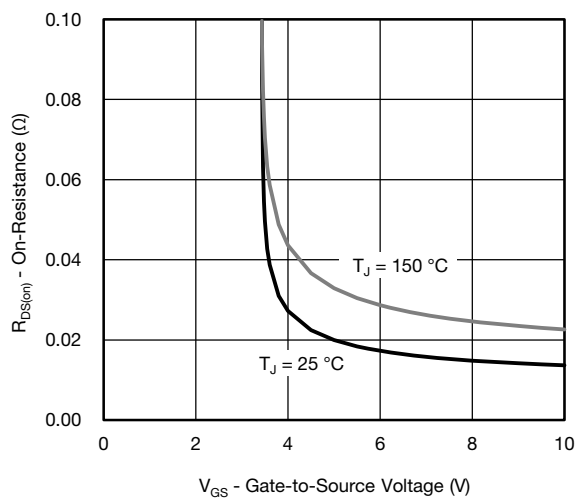
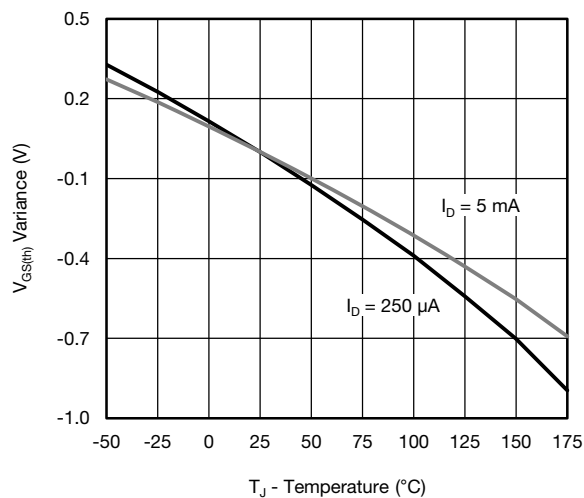
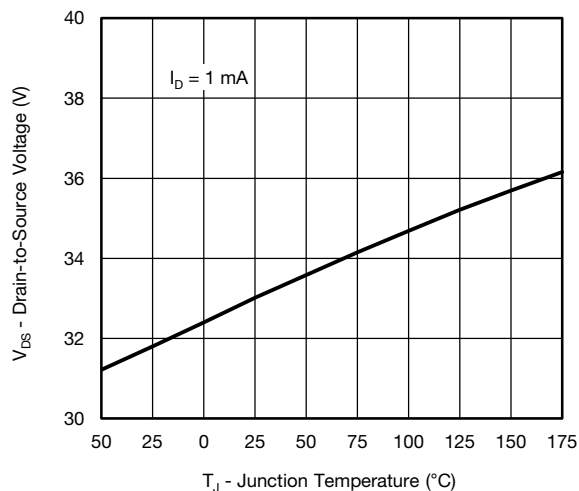
On-Resistance vs. Drain Current

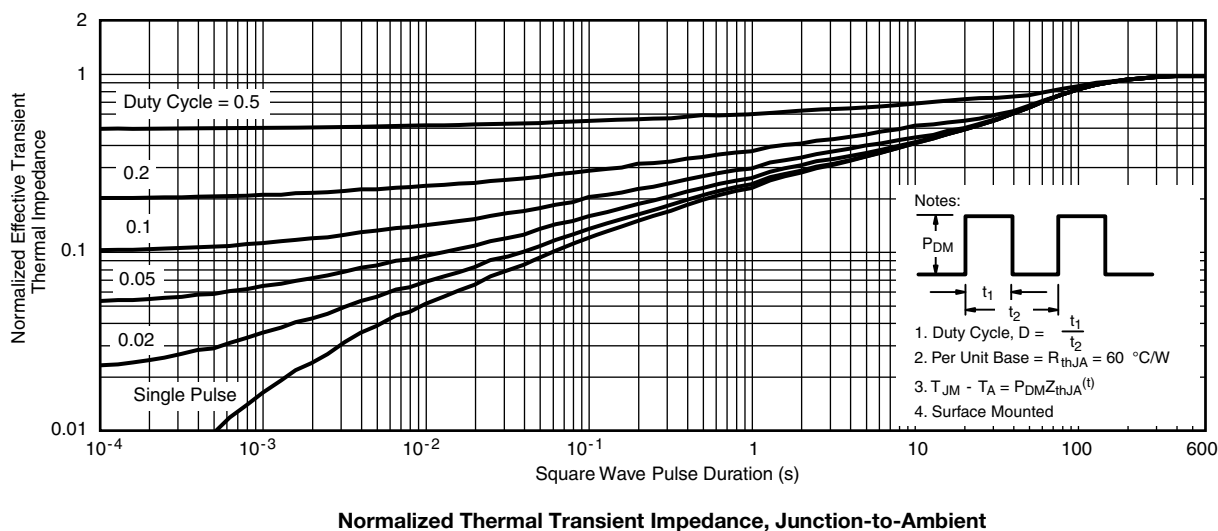

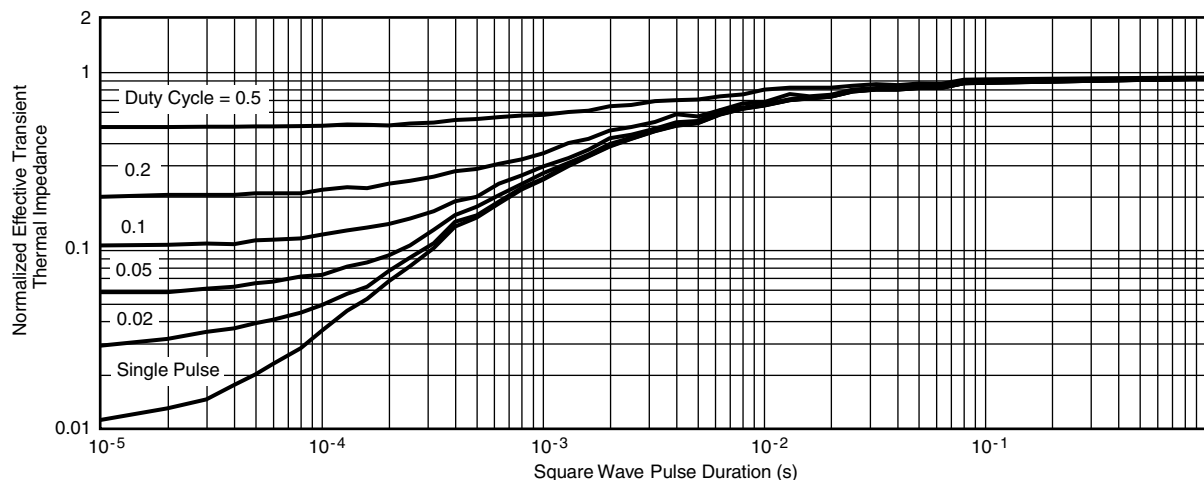

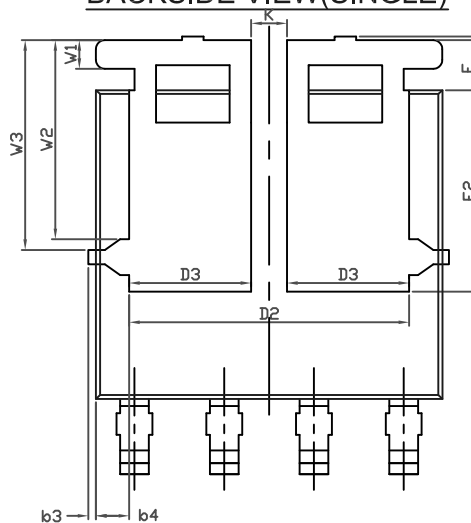
PowerPAK® SO-8L Case Outline

BACKSIDE VIEW(DUAL)

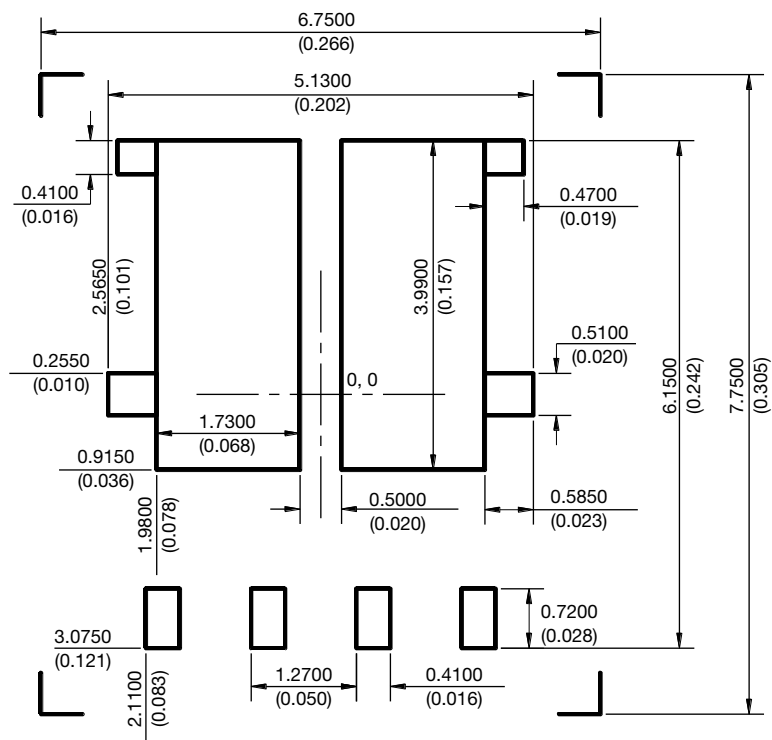
