


Figure 1. Logic Diagram




Figure 2. Connection Diagram



Figure 3. AC Test Circuit




Figure 4. AC Waveforms




Figure 5. 16-Lead Small Outline Integrated Circuit (SOIC) JEDEC MS-012,0.150 Narrow


