


Figure 1. MMBTA28 Device Package




Figure 2. PZTA28 Device Package




Figure 3. Typical Pulsed Current Gain vs. Collector Current




Figure 4. Collector-Emitter Saturation Voltage vs.
Collector Current




Figure 5. Base-Emitter Saturation Voltage vs.
Collector Current




Figure 6. Base-Emitter On Voltage vs.
Collector Current




Figure 7. Collector Cut-Off Current vs.
Ambient Temperature





Figure 8. Input and Output Capacitance vs. Reverse Voltage

Figure 10. Collector-Emitter Breakdown Voltage with Resistance Between Emitter-Base






Figure 11. Power Dissipation vs.
Ambient Temperature




Figure 12. MOLDED PACKAGE, SUPERSOT, 3-LEAD
