

## **Typical Inductance vs. Current Characteristics:**




## **Typical Inductance vs. Frequency Characteristics:**







## **Q-Factor vs. Frequency:**




## **Typical Temperature Rise vs. Current Characteristics:**


Direct mechanical impact to the product shall be prevented as the core material could flake or in the worst case could break.


