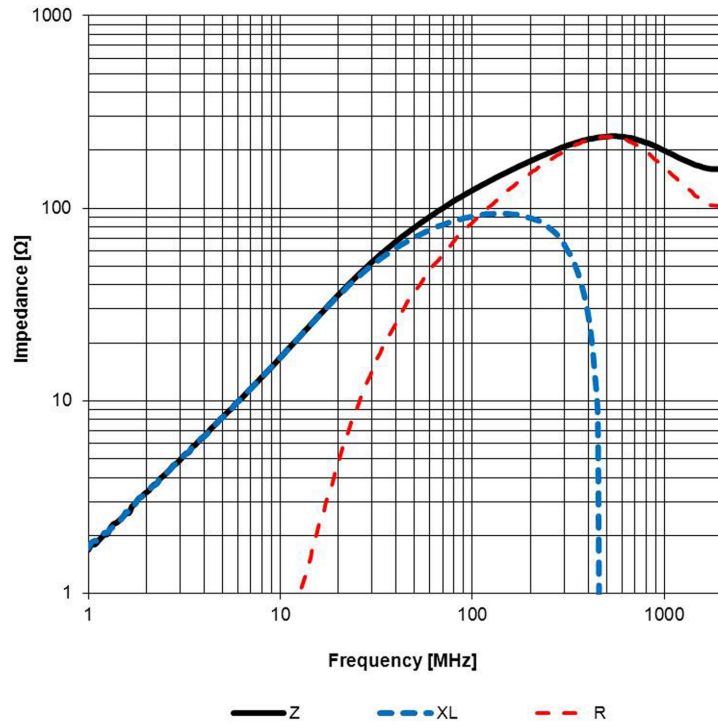

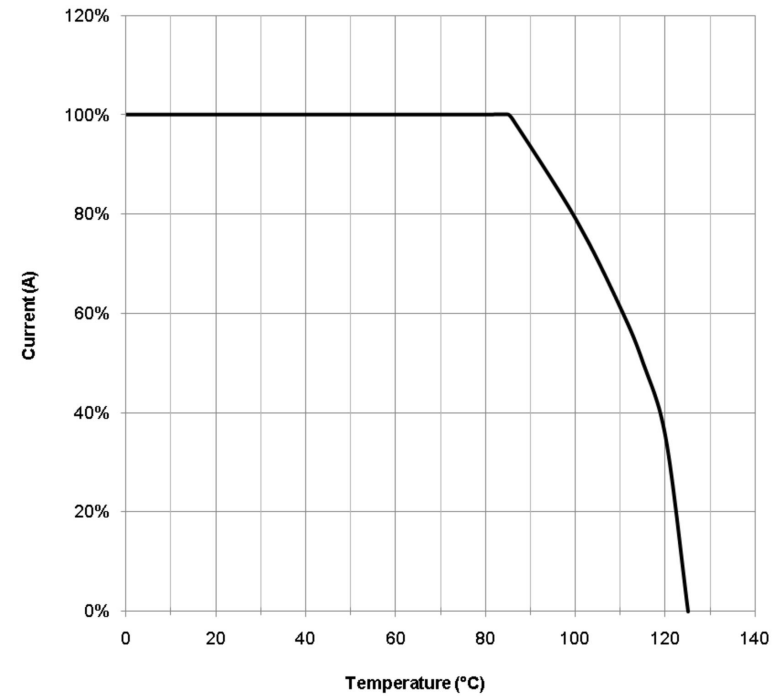


### F Typical Impedance Characteristics:

Follow all instructions mentioned in the datasheet, especially:
