C Schematic:

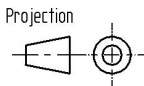

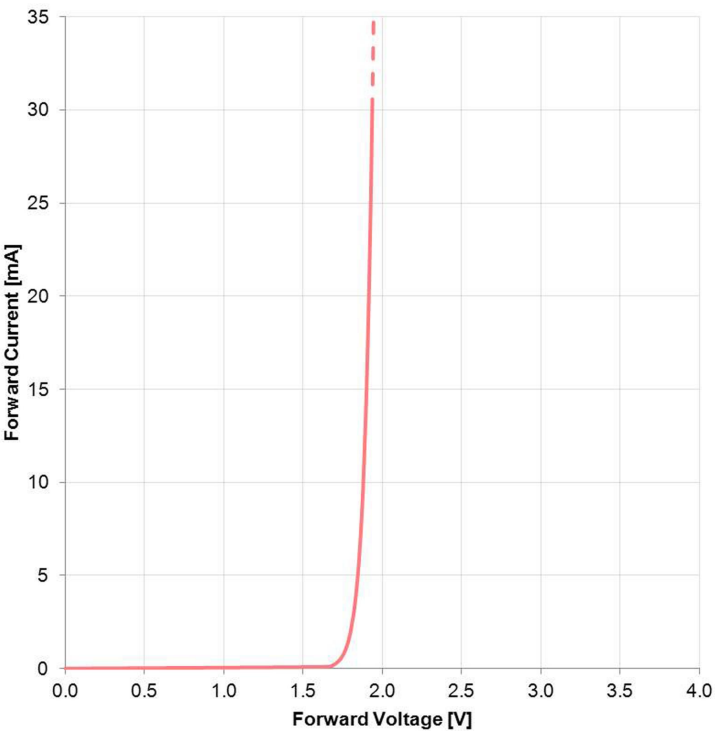

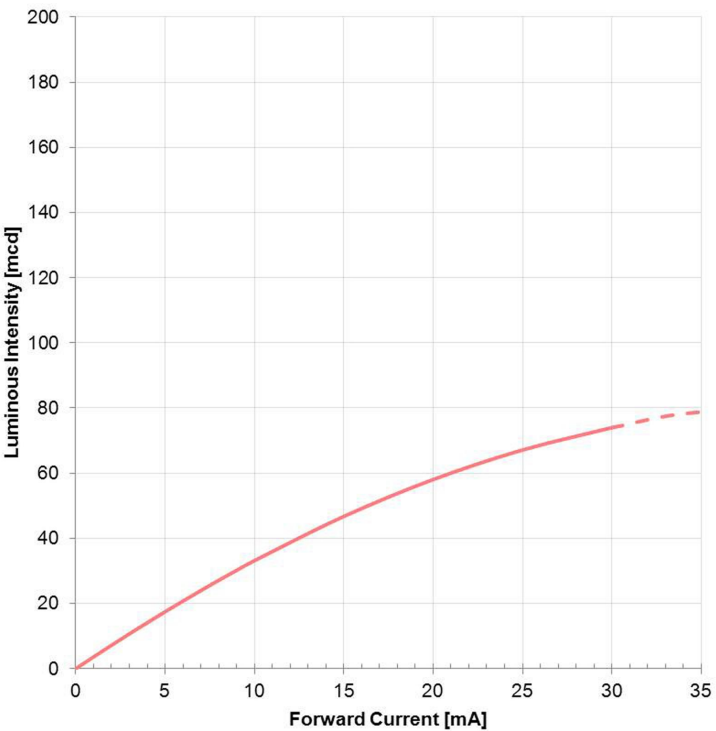

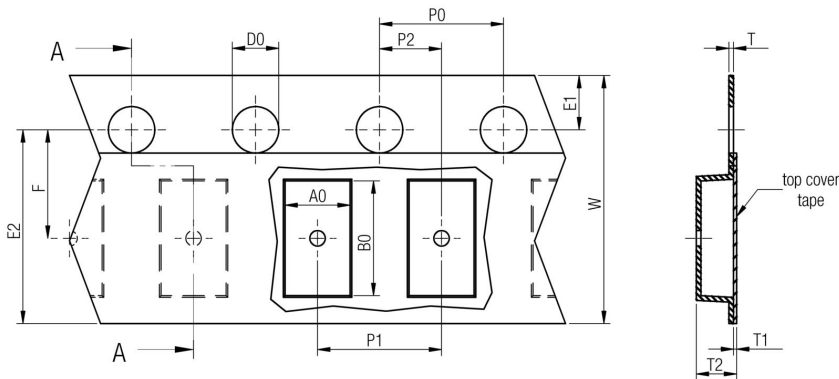
F5 Derating Curve:



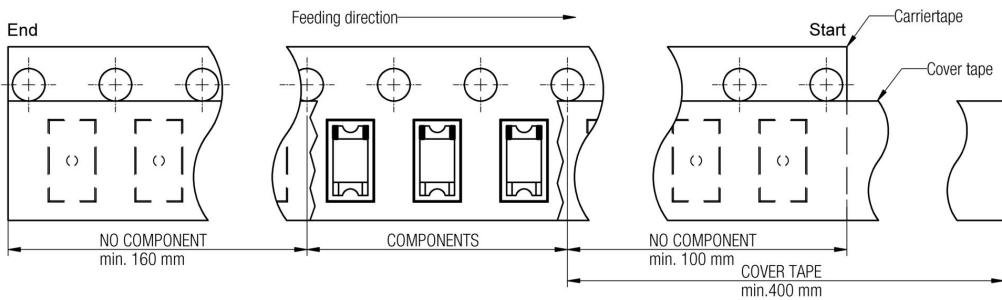
